hundred and seventeen; and in the meantime the representatives of the districts or combined districts in which they were grouped, or out of which they have been created shall be deemed to be the representatives of the aforesaid combined districts.

(d.) The first election of representatives for Cook County shall take place on the date of the next ordinary general election of members of the County Council, and the present

election of members of the County Council, and the present representatives shall continue in office until that date. (e.) On Wednesday, the twenty-fifth day of April, one thousand nine hundred and seventeen, the representation of the combined district of Newmarket, Mount Eden, and Onehunga Boroughs and Ellerslie Town District shall be reduced to one member, and the present representatives of that district shall continue to hold office until that date. (f.) The principal local authority in each of the combined districts in the Schedule hereto shall be that indicated by the letter (a).
