Bounded towards the north by Matai Road, 699 links; towards the east by a road, 770-9 links; towards the south by Lot 2 of Section 57 aforesaid, 668-6 links; and towards the west by said Lot 2, 766-1 links: be all the aforesaid linkages more or less.
