THE Maori Land Board for the Tairāwhiti Maori Land District hereby notifies that a meeting of the owners

of Nuhaka 2F 2A 7 Block is summoned and will be held, in pursuance of Part XVIII of the Native Land Act, 1909, at Wairoa on Wednesday, the 18th day of April, 1917, at 10 o'clock in the forenoon, for the purpose of considering the following proposed resolutions:—

“(1.) That the Board be requested to recommend that the Order in Council making the above-described land subject to Part XVI of the Native Land Act be revoked.

“(2.) That the said land be sold to Hugh Marshall, of Wairoa, sheep-farmer, at or for the price of £3 per acre, or alternatively
