Altering Boundaries of Kaitieke and Waimarino Counties.

# L.S.] LIVERPOOL, Governor. A PROCLAMATION.

WHEREAS it is provided by subsection two of section three of the Counties Amendment Act, 1913, that the boundaries of any one or more counties may be altered in accordance with a resolution proposing the alteration passed by the Council of each of such counties in which the principal Act is in force :

And whereas a resolution was passed by the Kaitieke County Council on the third day of March, one thousand nine hundred and seventeen, and sealed with the seal of the Council of the said county on the twenty-first day of March, one thousand nine hundred and seventeen: And whereas a similar resolution was pass d by the Waimarino County Council on the tenth day of March, one thousand nine hundred and seventeen, and sealed with the seal of the said county on the twenty-sixth day of March, one thousand nine hundred and seventeen, praying for the inclusion in the Kaitieke County of that part of the Waimarino County described in the said resolutions and in the First Schedule hereto, and also praying for the inclusion in the Waimarino County of that part of the County of Kaitieke described in the said resolutions and the Second Schedule hereto: And whereas it is expedient to make such alterations in accordance with the said resolutions :

with the said resolutions: Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the Waimarino County, shall, as on and from the first day of April, one thousand nine hundred and seventeen, be deemed to be added to and form part of the Kaitieke County; and that the area described in the Scoond Schedule hereto, being now part of the Kaitieke County, shall, as on and from the first day of April aforesaid, be deemed to be added to and form part of the Waimarino County; and, with

the like power and authority do proclaim and declare that the boundaries of the Counties of Kaitieke and Waimarino respectively shall as from the aforesaid date be those set forth under their respective headings in the Third Schedule hereto.

# FIRST SCHEDULE.

## AREA ADDED TO KAITIEKE COUNTY.

ALL that area in the Wellington Land District bounded by a line commencing at a point in the middle of the Manganuia-te-ao River in line with the middle of the rord forming the western boundary of Section 15, Block VIII, Manganui Survey District; thence to and along the middle of that road to and along the middle of the road forming the northern boundary of Section 18, said Block VIII, and to and along the eastern boundary of that section and its production to the middle of the said Manganui-a-te-ao River, and along the middle of that river to the place of commencement. Also all that area bounded by a line commencing at a point

Also all that area bounded by a line commencing at a point in the middle of the Manganui-a-te-ao River opposite the southernmost corner of Section 24, Block XI, Manganui Survey District; thence to and along the south-western boundary of that section and its production to the middle of the Raethi-Waimarino Road, along the middle of that road to a point opposite the southernmost corner of Section 24, Block VII, Manganui Survey District; thence to and along the south-western boundary of that section, part of the south-eastern boundary of Section 4, Block VI, to its southernmost corner, and along its south-western boundary and to the middle of the Makino Road, and along the middle of that road to a point in line with the south-western boundary of Section 2, said Block VI; thence to and along that boundary and the south-western boundaries of Section 1, Block VI, and Section 4, Block II, part of the north-western boundary of the last-mentioned section, and the south-western boundary of Section 3, Block I, Manganui Survey District, and that boundary produced to the middle of the Ruatiti-Erua Road; and thence along the present boundary between the Kaitiekc and Waimarino Counties to the place of commencement

## SECOND SCHEDULE.

## AREA ADDED TO WAIMARINO COUNTY.

ALL that area in the Wellington Land District bounded by a line commencing at a point in the middle of the Ruatiti-Erua Road near the western corner of Section 3, Block II, Manganui Survey District; thence to and along the western boundary of that section and part of the southern boundary of Section 8, Block XIII, Kaitieke Survey District, to the Kokako Road, to and along the middle of that road to a point in line with the south-western boundary of Section 5, said Block XIII; thence to and along the south-western boundaries of Sections 5 and 3 and the north-western boundary of Section 4, Block XIII aforesaid, and its production to the middle of the Maungaroa Road, along the middle of that road to the present boundary between the Kaitieke and Waimarino Counties, and along that boundary to the point of commencement.

### THIRD SCHEDULE.

#### KAITIEKE COUNTY.

All that area in the Wellington Land District bounded towards the north-west and north-east generally by the Wanganui River from the northern boundary of Whirinaki Survey District to the point where the boundary-line between West Taupo and East Taupo Counties intersects the said Wanganui River; thence towards the south-east by East Taupo County to Pare-te-taitonga Trig. Station; thence towards the south generally by a right line to Te Kahatu Trig. Station; thence by a right line to the source of the Ngahuinga Stream; thence by that stream to the eastern boundary-line of Section 13, Block VIII, Manganui Survey District; thence by a right line running due south to the middle of the Manganui-a-te-ao River, along the middle of that river to a point opposite the southernmost corner of Section 24, Block XI, Manganui Survey District; thence to and along the southwestern boundary of that section and its production to the middle of the Raetihi-Waimarino Road, along the middle to that road to a point opposite the southernmost corner of Section 24, Block VII, Manganui Survey District; thence to and along the south-western boundary of that section, part of the south-eastern boundary of Section 4, Block VI, to its southernmost corner, and along its south-western boundary and to the middle of the Makina Road, along the middle of that road to a point in line with the south-western boundary of Section 2, said Block VI; thence to and along that

boundary and the south-western boundaries of Section 1, Block VI, and Section 4, Block II, part of the north-western boundary of the last-mentioned section, and the south-western boundary of Section 3, Block I, Manganui Survey District, and that boundary produced to the middle of the Ruatiti-Erua Road, and along the middle of that road to a point near the south-western corner of Section 3, Block II, Manganui Survey District; thence to and along the western boundary of that section and part of the southern boundary of Section 8, Block XIII, Kaitieke Survey District, to the Kokako Road, to and along the middle of that road to a point in line with the south-western boundary of Section 5, said Block XIII; thence to and along the south-western boundary of Sections 5 and 3 and the north-western boundary of

line with the south-western boundary of Section 5, said Block XIII; thence to and along the south-western boundaries of Sections 5 and 3 and the north-western boundary of Section 4, Block XIII aforesaid, and its production to the middle of the Maungaroa Road, along the middle of that road to the northernmost corner of Section 3, Block IV, Whirinaki Survey District; thence by the northern boundaries of Blocks IV, III, II, and I, Whirinaki Survey District, to the Wanganui River, the place of commencement, excluding the Manunui Town District.

#### WAIMARINO COUNTY.

All that area in the Wellington Land District bounded towards the north generally by the Kaitieke County hereinbefore described, and by East Taupo County, towards the east by Rangitikei County, towards the south generally by Wanganui County, and towards the west generally by Waitotara County and Whangamomona County, excluding the Borough of Ohakune and the Raetihi and Rangataua Town Districts.
