GENERAL DESCRIPTION.

The block is situated between Porangahau and Whangachu Station (Mr. C. H. St. Hill's), the nearest point being two miles distant from the township and the farthest seven miles and three-quarters.

The district is all good grazing-ground, suitable for both sheep and cattle rearing.

The altitudes vary from sea-level to 1,000 ft., and the country comprises flat, undulating, and hilly land, giving shelter from south and westerly winds. There is no broken country on the block, except the face fronting the sea, which is a high terrace with steep sides.
