the access is then by the unformed and unbridged Te Uri Road line running through Messrs. Donnelly and Co.'s property, but over which carting is carried on via the station dray-track. dray-track. Teams are constantly travelling into the Mana-waangiangi Settlement with supplies from the main road,

and material is of easy transport to the sections generally.
