WHAKATANE COUNTY COUNCIL

Adjustment Representation in the Council and re New Ridings. In exercise of the powers conferred on it by section 23 of the Counties Act, 1908, the County Council resolves, by way of special order, as follows:

1. The present division of the County of Whakatane into 1. The present division of the County of Whakatane into five ridings is revoked, and in lieu thereof the said county shall be divided into eight ridings, to be called respectively Matata Riding, Tarawera Riding, Rangitaiki Riding, Omataroa Riding, Taneatua Riding, Opouriao Riding, Nukuhou Riding, and Waimana Riding, which said ridings are respectively described in the Schedule hereto.

2. The said Whekatane County Council shall consist of

2. The said Whakatane County Council shall consist of ten members, who shall be elected as follows:—

(a.) The electors of the Tarawera Riding and the Rangitaiki Riding shall each elect two Councillors.

(b.) The electors of the Matata Riding, Omataroa Riding,

(b.) The electors of the Matata Riding, Omataroa Riding,
Taneatua Riding, Opouriao Riding, Nukuhou Riding,
and Waimana Riding shall each elect one Councillor.

3. The alteration hereby made shall take effect at the
general election of Councillors to be held on the 14th day
of November, 1917, except in so far and to such extent as
may be necessary for preparing any roll or otherwise proriding for that election. viding for that election.
