That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of one thousand pounds, authorized to be raised by the Piako County Council, under the Local Bodies' Loans Act, 1913, for the purpose of metalling Harbottle's Road for the first time, the said Piako County Council hereby makes and levies a special rate of fifteen-sixteenths of a penny per pound upon the rateable value of all rateable property within the following boundaries:—
