## RESOLUTION MAKING SPECIAL RATE,

In pursuance and exercise of the powers vested in it in that

In pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Mangonui County Council hereby resolves as follows:—

That, for the purpose of providing the interest and other charges on a loan of £8,000, authorized to be raised by the Mangonui County Council, under the above-mentioned Act, for the following purposes—viz., (a) for making new roads, culverts, and general road improvements and metalling from Awanui to Waikuku Bridge, Kaitaia, £6,000; and (b) for the erection of breastworks and the construction and metalling erection of breastworks and the construction and metalling of Beach Road, Mangonui—the said Mangonui County Council hereby makes and levies a special rate of 9/32nds of a penny in the pound upon the rateable value of all rateable property of the Mangonui County, comprising the whole of the County of Mangonui; and that such special rate shall be an annualof Mangoliui, and that stein special rate shall be an almost a recurring rate during the currency of such loan, and shall be payable yearly on the first day of October in each and every year during the currency of such loan, being a period of 36½ years, or until the loan is fully pald off.

# SCHOOL FOR THE DEAF, NEAR SUMNER, CHRISTCHURCH.

POR Deaf Children of sound intellect. The pupils are taught to understand and use ordinary speech. The

taught to understand and use ordinary speech. The full charge for board and education is £40 a year, but less is accepted from parents who cannot afford to pay this amount. In case of necessity admission is free.

By the Education Act it is compulsory for deaf children to come under instruction at the age of six, and to continue until the age of twenty-one unless the Education Department previously grants exemption. Though a child is, as a rule, best fitted to begin the school course at the age of six, advice should be obtained as soon as any sign of deafness is observed.

The following classes of deaf children are admitted to the School for the Deaf (sound intellect being always a necessity):—

necessity)

1. Children born deaf, or who have lost their hearing

Children born deaf, or who have lost their hearing before learning to speak.
 Children who can hear a little, but are too deaf to be taught in a public school.
 Children who have lost their hearing after having learned to speak.
 The Act imposes upon every parent, teacher of a school (either public or private), constable, or officer of a charitable or kindred institution who is aware of the place of residence (either temporary or permanent) of a deaf child, and the householder in whose house any such child resides, an obligation to send notification of the fact to the Minister of Education, giving the name, age, and address of the child; and any neglect or failure to comply with this provision involves liability to a fine.
