WHEREAS, there being no Harbour Board empowered WHEREAS, there being no Harbour Board empowered to grant the license hereinafter mentioned under the Harbours Act, 1908 (hereinafter called "the said Act"), Patrick Orchard, of Whakatane (hereinafter called "the licensee"), has applied to the Governor-General in Council for a license under the said Act to use and occupy a part of the foreshore and land below low-water mark at Whale Island, Bay of Plenty, in order to erect and maintain a landing-stage thereon; and, in accordance with the one-hundred-and-fiftieth section of the said Act, has deposited plans (sheets 1 and 2) in the office of the Marine Department at Wellington (marked M.D. 4966) showing the area of foreshore and land below low-water mark intended to be occupied, and the manner in which it is proposed to erect the said and the manner in which it is proposed to erect the said landing-stage:

And whereas it has been made to appear to the Governor-General in Council that the proposed work will not be or tend to the injury of navigation, and the said plans have, prior to the making of this Order in Council, been approved

by the Governor-General in Council:

And whereas it is expedient that a license should be granted and issued to the licensee under the said Act, for the purposes aforesaid, on the terms and conditions hereinafter expressed:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of

the Harbours Act, 1908, or its amendments, or any regulations made thereunder, and that are now or may hereafter of all other powers and authorities enabling him in that of all other powers and authorities enabling him in that behalf, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the purpose or object for which the said license is required by the licensee as aforesaid; and, in further pursuance and exercise of the said power and authority, and with the like advice and consent as aforesaid, doth hereby license and permit the license to use and occupy that part of the foreshore and land below low-water mark on which the said landing stage is to be exected as shown on the plan M D 4966 landing-stage is to be erected as shown on the plan M.D. 4966 (sheet 1) so deposited as aforesaid, for the purpose of erecting and maintaining the said landing-stage, such license to be held and enjoyed by the licensee upon and subject to the terms and conditions set forth in the Schedule hereto.

## SCHEDULE.

1. In these conditions the term "Minister" means the 1. In these conditions the term "Minister" means the Minister of Marine as defined by the Shipping and Seamen Act, 1908, and includes any officer, person, or authority acting by or under the direction of such Minister.

2. The concessions and privileges conferred by this Order in Council shall extend and apply only to that part of the foreshore and land below low-water mark necessary for the erection of the said landing-stage, as shown on the plan marked M.D. 4966 (sheet 1).

3. In consideration of the concessions and privileges granted by this Order in Council the licensee shall, on being supplied with a copy thereof, pay to the Minister the sum of £2 10s., and thereafter an annual sum of £1, in advance, dating from the date hereof, the first of such annual payments to be made on the licensee being supplied with a copy of this Order in Council.

4. All persons shall, at all reasonable times, and upon payment of the proper dues, have free and full liberty to use the said landing-stage and all rights of ingress and egress thereon and therefrom.

5. His Majesty or the Governor-General, and all officers in the Government service acting in the execution of their duty, shall at all times have free ingress, passage, and egress into, through, over, and out of the said landing-stage without payment.

6. The licensee shall maintain the above-mentioned landingo. The licensee shall maintain the above-hentioned landing-stage in good order and repair, and shall at all times exhibit therefrom, and maintain at his own cost, suitable and necessary lights for the guidance of vessels; provided that no light shall be exhibited until after it has been approved by the Minister.

7. Any person authorized by the Minister may, at all reasonable times, enter upon the said landing-stage and view the state of repair thereof, and upon such Minister leaving the state of repair thereof, and upon such Minister leaving at or posting to the last known address of the licensee in New Zealand a notice in writing of any defect or want of repair in such landing-stage, requiring him, within a reasonable time, to be therein prescribed, to repair the landing-stage, he shall, with all convenient speed, cause such defect to be removed or such repairs to be made.

8. Nothing herein contained shall authorize the licensee to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs or any regulations of the Minister of Customs, or with any provisions of the Harbours Act, 1908, or its amendments, or any regulations made there-under, and that are now or may hereafter be in force.
