MY LORD,—With reference to my despatch, Dominions No. 766, of the 29th November, 1917, I have the honour to transmit to Your Excellency, for the information of your Ministers, copies of a notice issued by the Nobel Committee of the Norwegian Parliament, regarding nominations for the Nobel Peace Prize for 1919.

2. I should be glad if your Ministers would cause the conditions of the prize to be made known to those bodies and persons who are qualified to nominate candidates.

NOBEL PEACE PRIZE.

ALL proposals of candidates for the Nobel Peace Prize, which is to be distributed December 10th, 1919, must, in order to be taken into consideration, be laid before the Nobel Committee of the Norwegian Parliament by a duly qualified person *before the 1st of February, 1919*.

Any one of the following persons is held to be duly qualified: (a) Members and late members of the Nobel Committee of the Norwegian Parliament, as well as the advisers appointed at the Norwegian Nobel Institute; (b) members of Parliament and members of Government of the different States, as well as members of the Interparliamentary Union; (c) members of the International Arbitration Court at the
