"3. Life-jackets previously passed.—Until the 1st January, 1920, any life-jacket which has been previously passed by a Marine Department Surveyor as part of the statutory equipment of a vessel may be accepted as part of the statutory equipment of the same vessel so long as it remains in good condition. On and after that date no life-jacket should be passed unless it complies with the conditions stated in paragraph 2."



WHEREAS by section twenty-six, subsection one, of VV the Appropriation Act, 1915, it is provided that, notwithstanding any Act to the contrary, it shall not be lawful or competent for any local authority or for any Harbour Board, during the present war with Germany, to borrow or contract to borrow any money (otherwise than by way of bank overdraft within the limit of its powers, if any, in that behalf), whether from the State Advances Office or from any other source whatever, and whether in pursuance of a special Act or under any other authority whatever, without the precedent consent of the Governor-General in Council:
