Altering Boundaries of Counties of Mongonui, Whangaroa, Hokianga, Bay of Islands, Whangarei, and Hobson.

A PROCLAMATION.

WHEREAS in pursuance of section one hundred and ten of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1917, a Commission was appointed to inquire and report as to what alterations (if any) of the boundaries of the Counties of Hokianga, Hobson, Whangarei, Bay of Islands, Mongonui, and Whangaroa were desirable:

And whereas the said Commission has duly reported that the boundaries of the said Counties should be altered in the manner described in the report of the said Commission:

And whereas it is expedient to alter the boundaries of the said Counties in such manner as is deemed to be in accordance with the said report:

Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that on and after the first day of May, one thousand nine hundred and eighteen, the boundaries of the Counties of Mongonui, Whangaroa, Hokianga, Bay of Islands, Whangarei, and Hobson shall be those set forth under their respective headings in the Schedule hereto, in lieu of the boundaries of the said Counties as at present defined.

SCHEDULE.

REDESCRIPTION OF COUNTIES.

Mongonui County.

ALL that area in the Land District of Auckland bounded generally towards the south, commencing at the north head of the Whangape Harbour on the Tasman Sea, thence gene-

rally following the tidal waters of the Awaroa Estuary to its confluence with the Awaroa River at the Awaroa Bridge, on the north-west corner of Section 11, Block X, Whangape Survey District; thence by the centre of the Awaroa River until it intersects the road on the north-west angle of Section 1, Block X, Whangape Survey District; thence across that road, and by the northern boundary of the said Section 1, and by the western boundaries of Sections 68 and 69, and the northern boundaries of Sections 69, 67, and 66, and part of Section 60, of Block II, Whangape Survey District; thence by the western and northern boundaries of Section 35, Block XV, Takahue Survey District, and by the northern boundary of the State forest reserve containing 2,600 acres (*Gazette*, 1st October, 1903, p. 2122); thence by the western boundary of Mangamuka West No. 2, and the western and northern boundaries of the said Mangamuka West Block, and the northern boundary of Mangamuka East Block, until it is intersected by the production in a southerly direction of the western boundary of Section 71, Block VII, Maungataniwha Survey District; thence in a northerly direction by the said production of such western boundary, and by such western boundary, and by the northern boundaries of Sections 71 and 69, Block VII, Maungataniwha Survey District; thence by portion of the south-western boundary of Section 95, and by the south-western boundary of Section 96, Block VII, Maungataniwha Survey District, and by the north-west boundaries of Sections 96, 97, 98, 99, 104, 105, 108, 109, and 151 of, Blocks VII, III, and IV, Maungataniwha Survey District; thence by the northern boundary of Section 151, and the north-western boundaries of Sections 113 and 114, Block IV, Maungataniwha Survey District, and by the north-western boundary of Section 1 of Blocks IV, Maungataniwha, and XI, Mongonui Survey Districts; thence by the south-west boundaries of the Totara Kauri-gum Reserve Extension, which lies to the north-east of Section 103, Block XI, Mongonui Survey District (Berghan's Old Land Claim), to "Stony" Stream; thence generally in a northerly direction by the centre of "Stony" Stream aforesaid to Section 61, Block VII,

Mongonui Survey District; thence by the western boundaries of the said Section 61 and of Section 9, Block VII, Mongonui Survey District, and part of the western boundary of Motukahakaha No. 1, and the western boundary of Section 73, Block III, Mongonui Survey District, to the sea; thence generally towards the north-east, the north, and the west respectively by the ocean to the point of commencement, being the northern promontory of the North Island of New Zealand: together with the adjacent islands, but excluding the islands known as the Three Kings.

Whangaroa County.

All that area in the Land District of Auckland bounded generally towards the west and north-west by the County of Mongonui hereinbefore described, from the eastern boundary of Mangamuka East No. 1A to the sea; thence generally towards the north-east by the ocean to the mouth of the Takou River; thence by the centre of that river to the north-west boundary of Section 4, Blocks II and III, Kerikeri Survey District; thence by the north-west boundary of Section 4 aforesaid, and by the north-east boundary of Section 5, subdivision of Kapiro Kauri-gum Reserve; thence by the western boundary of the said Section 5, and by the north-western boundaries of Section 3, subdivision of Kapiro Kauri-gum Reserve, and of Section 1, Block II, Kerikeri Survey District, to Te Whau Trig. Station; thence by the north-west boundary of the Kapiro Kauri-gum Reserve adjoining Sections 8 and 3, Blocks VIII and XII, Kaeo Survey District, to the north-east angle of Section 12, Block XII, Kaeo Survey District; thence by the northern boundaries of Sections 12 and 14, Block XII, Kaeo Survey District; thence by the western boundary of Section 14, the northern and western boundaries of Section 10, and portion of the western boundary of Section 15A, all of Block XII, Kaeo Survey District, until such last-mentioned boundary strikes a surveyed road; thence generally in a southerly direction by that road to the north-west angle of Section 16, Block XVI, Kaeo Survey District; thence by the western boundary of that section, and by the north-eastern and portion of the north-western boundaries of Section 28, Blocks XV and XVI, Kaeo Survey District; thence by the north-west boundaries of the Mangaparua Kauri-gum Reserve (passing through Mangangina Trigonometrical Station), and of Sections 15, 8, and 9, Blocks XV and XVI, Kaeo Survey District; thence by Crown land adjoining portion of the south-western boundary of Section 3, Block XVI, Kaeo Survey District, to the Pukatea Stream; thence by the centre of that stream to its confluence with the Waipapa River; thence generally in a south-westerly direction by the centre of the Waipapa River aforesaid to its confluence with the Mangapapa River; thence generally in a north-westerly direction by the centre of that river to its confluence with the Whakatereterekia Stream, and by the centre of that stream until it intersects the northern boundary of Block XVI, Maungataniwha Survey District; thence by the northern boundary of that block, and the north-eastern boundary of the Omahuta State Forest Timber Sections Nos. 16, 6, and 2, to Ratakamaru Trigonometrical Station; thence by portion of the north-western boundary of the said Timber Section 2 to the easternmost angle of the Mangamuka East Block; thence generally by the north-eastern boundary of that block to the point of commencement: together with the Cavalli Islands, Step Island, Flat Island, Stephenson's (or Ririwha) Island, and the other islands adjacent to the said county.

Hokianga County.

All that area in the Land District of Auckland bounded generally towards the north by the Mongonui County hereinbefore described, from the north head of the Whangape Harbour to the easternmost angle of Mangamuka East No. 1A Block; thence towards the north-east by the Whangaroa County to the confluence of the Mangapapa and Waipapa Rivers; thence by the centre of the Waipapa River to its confluence with the Whakanekeneke Stream; thence by the centre of that stream until it is intersected by the north-eastern boundary-line of Section 2, Block V, Omapere Survey District; thence by that line to the north-western corner of Section 40, Block V, Omapere Survey District; thence by the western boundaries of Sections 40, 41, 62, 63, and 21, all of Block V, Omapere Survey District; thence by the southern boundaries of Sections 21 and 57, Block IX, Omapere Survey District, and by the western boundaries of Sections 58, 61, and 60, Block IX, Omapere Survey District, to the Utakura River; thence by the centre of that river to the western boundary of Section 7, Block X, Omapere Survey District; thence by the western boundary of the said Section 7, and by the western boundary of Crown land adjoining Section 5, Block X, Omapere Survey District, to the south-east angle of the said Section 5, on the northern boundary of Block XIV, Omapere Survey District; thence by the northern and western

boundaries of Block XIV, Omapere Survey District, and by the western boundary of Block II, Punakitere Survey District, to the Mangatua Stream; thence by the centre of that stream to its confluence with the Punakitere River; thence by the centre of that river to the western boundary of the Wharepoke Block; thence by that boundary to the north-east angle of the Ninihi Block; thence by the northern and western boundaries of the Ninihi Block, and by the western boundaries of Sections 1 and 2, and portion of the western boundary of Section 3, Block X, Punakitere Survey District, to the most northerly point of the Te Marini Forest Reserve situated in Blocks IX and XIII, Punakitere Survey District; thence by the north-western boundary of such forest reserve, and by the northern boundary of Section 4, Block XIII, Punakitere Survey District, and by a road forming the western boundaries of Sections 4 and 6, Block XIII, Punakitere Survey District; and thence by the western boundary of Section 7, Block XIII, Punakitere Survey District, and by a production of such boundary to the headwaters of the Mangakahia River, near the south-west angle of the said Section 7; thence in a south-westerly direction by the centre of the said river until it reaches the survey-district boundary between the Punakitere and Tutamoe Survey Districts; thence due west by the said boundary, and by the boundary between the Waoku and Waipoua Survey Districts, to the western boundary of Block IV, Waipoua Survey District; thence due south by such boundary, and by the western boundary of Block VIII, Waipoua Survey District, to the Waipoua River: thence by the centre of that river to the sea; thence by the ocean to the north head of the Whangape Harbour, being the point of commencement.

Bay of Islands County.

All that area in the Land District of Auckland bounded towards the north-west by the Whangaroa County hereinbefore described, from the confluence of the Mangapapa and Waipapa Rivers to the sea; thence towards the north-east by the ocean to the northern boundary of Subdivision No. 9 of the Whangaroa or Ngaioitonga No. 4 Block; thence by the northern boundary of said Subdivision No. 9, and by portion of the northern and by the western boundary of the remainder of the said Whangaroa or Ngaioitonga Block, to the western boundary of the Tutamatai Block; thence by the western boundary of the said block, and by the western boundaries of a scenic reserve in Block XII, Russell Survey District, and by the western boundaries of Waikokopu Block, Punaruku No. 1 Block, and the north-western and western boundaries of Punaruku No. 2 Block, and by portion of the western boundary of Paremata-Mokau Block until such latter boundary intersects the western boundary of Block IV, Hukerenui Survey District; thence by such western boundary of Block IV, Hukerenui Survey District, to the northern boundary of Section 11 of Block IV, Hukerenui Survey District; thence by the northern boundary of the said Section 11 and of Sections 16 and 11, Block III, Hukerenui Survey District; thence by the western boundaries of Sections 11, 12, 13, and 5 of Block III, and portion of the western boundary of Section 6, Block VII, Hukerenui Survey District; thence by the northern and western boundaries of Section 3, and by the western boundary of Section 4, Block VII, Hukerenui Survey District, and by the western boundary of the Puhupuhi No. 4 (Native Land Court Block) to the Waiotu River; thence by the centre of that river until it reaches the south-east side of the Tapuhi-Hukerenui Road in Section 17, Block X, Hukerenui Survey District; thence by the south-eastern side of that road to the Whangarei-Kawakawa main road; thence by the north-eastern side of that road until it reaches the western boundary of Section 19, Block X, Hukerenui Survey District; thence by the said western boundary of Section 19, and by the northern boundary of Section 38, Block X aforesaid, and by the northern and western boundaries of Te Mata Kauri-gum Reserve and Te Mata Kauri-gum Extension to the western boundary of Block X aforesaid; thence by such western boundary until it reaches Section 32, Block IX, Hukerenui Survey District; thence by the northern, western, and south-western boundaries of Section 32 aforesaid, and by the western boundary of Section 32, Block X, Hukerenui Survey District; thence by the northern boundaries of Sections 3, 4, and 5, Block XIII, Hukerenui Survey District, and by the eastern boundaries of Sections 24 and 23, the northern boundary of Section 23, and the western boundaries of Sections 23 and 24, Block IX, Hukerenui Survey District; thence by the northern and western boundaries of Section 13, Block XIII, Hukerenui Survey District, and by the northern boundaries of Mangakowhara and Kaikou No. 3 Blocks; thence by part of the western boundary of Kaikou No. 3 to the northern boundary of that part of the Nukatawhiti Block known as the middle part; thence by such northern boundary of the middle part of Nukatawhiti Block, and by a production of such boundary to the Awarua River; thence

by the centre of such river to its confluence with the Mangakahia River; thence by the centre of such last-mentioned river to the most easterly angle of the Aukumeroa Block; thence by the north-eastern boundary of such block to the Mangakahia River; thence by the centre of that river to the most easterly angle of Section 3, Block XV, Punakitere Survey District; thence by the northern and western boundaries of the said Section 3 to the Mangakahia River; thence by the centre of that river to the boundary of the Hokianga County hereinbefore described, near the south-western corner of Section 7, Block XIII, Punakitere Survey District; and thence in a northerly direction by the said Hokianga County to the point of commencement: together with all the islands in the Bay of Islands, and all other islands adjacent to the said county.

Whangarei County.

All that area in the Land District of Auckland bounded towards the north by the Bay of Islands County hereinbefore described, from a point on the Mangakahia River at the south-eastern corner of Section 1, Block II, Tutamoe Survey District, to the sea; thence by the ocean to the north-eastern angle of the Otamatea County, as constituted by the Counties Act, 1886; thence generally towards the south by the said Otamatea County to the Mongonui River at the north-eastern angle of Section 166, Parish of Omaru; thence by the centre of Mongonui River to its confluence with the Tauraroa River, and by the centre of the Tauraroa River to the eastern boundary of Section 44, subdivision of Walton's Grant; thence by the eastern boundary of the said Section 44, and by portion of the northern boundary of Section 43, subdivision of Walton's Grant, until it strikes the eastern boundary of Block VII, Tangihua Survey District; thence by such eastern boundary, and by portion of the eastern boundary of Block I, Tangihua Survey District, to the southern boundary of Section 8, Block I, Tangihua Survey District; thence by the north-eastern boundary of Crown land where it adjoins the said Section 8 and Sections 9, 10, 11, and 12, Block I aforesaid; thence by the south-eastern boundaries of Sections 13 and 17, Block I aforesaid, to the Waiotama River; thence by the centre of that river to the eastern boundary of Section 4, Block IV, Mangaru Survey District; thence by such eastern boundary, and by the northern boundaries of the said Section 4 and of Section 1, Block IV aforesaid, to the Wairoa River; thence by the centre of that river to its confluence with the Mangakahia River, and by the centre of the Mangakahia River to the south-eastern angle of Section 8, Block XV, Mangakahia Survey District; thence by the north-eastern boundary of the Mangaru Block where it adjoins Sections 8, 9, 10, 11, and 2, Block XV aforesaid; thence by the eastern and north-eastern boundaries of forest reserve adjoining Sections 2 and 1, Block XV aforesaid; thence by the north-eastern boundaries of a forest reserve, and of a State forest reserve of 2,054 acres, and by the north-eastern and northern boundaries of a further forest reserve which adjoins Sections 9 and 8A, Block X, Mangakahia Survey District; thence by a portion of the north-eastern boundary of Section 13, and by the north-eastern and north-western boundaries of Section 12, and the north-eastern and north-western boundaries of Section 10, and the eastern boundaries of Sections 25 and 24, all of Te Karaka Block; thence by the north-western boundary of Section 24 of Te Karaka Block; thence by the northern boundaries of Sections 10, 14, 9, and by the western boundary of Section 9, Block XII, Tutamoe Survey District; thence by the northern boundaries of Sections 8, 7, 9, 10, 11, 12, 13, and 14, subdivisions of forest reserve situated in Blocks XVI, XII, XV, and XI, Tutamoe Survey District; thence by the eastern boundary of Section 4, Block X, Tutamoe Survey District, and by the eastern boundary of Block VI, and part of the eastern boundary of Block II, Tutamoe Survey District, and by the eastern boundary of Section 4A, Block II, Tutamoe Survey District; thence in an easterly direction by portion of the southern boundary of Section 1, Block II, Tutamoe Survey District, to the Mangakahia River at the point of commencement: together with all the islands known as the Hen and Chickens (Taranga and Maro Tiri) and the Poor Knights, and any other islands adjacent to the said county.

Hobson County.

All that area in the Land District of Auckland bounded towards the north by the Hokianga County hereinbefore described, from the mouth of the Waipoua River to a point on the Mangakahia River at the north-western corner of Section 13A, Block III, Tutamoe Survey District; thence generally towards the east and north-east by the Whangarei County hereinbefore described, to a point on the Mongonui River at the most northern angle of Section 166, Block I, Matakoho Survey District; thence towards the south by the Otamatea County, as constituted by the Counties Act, 1886,

to the Wairoa River, and across that river; thence by the western side of the said river and the Kaipara Harbour to the sea, and thence by the ocean to the point of commencement.

Declaring certain Area added to the County of Waimarino to be included in Karioi Riding thereof.

A PROCLAMATION.

WHEREAS by Order in Council dated the twenty-fifth day of March, one thousand nine hundred and eighteen, and published in the *New Zealand Gazette* of the twenty-eighth day of March, one thousand nine hundred and eighteen, the boundaries of the County of Waimarino and Borough of Ohakune were altered by the exclusion of a certain area from the Borough of Ohakune and the inclusion of such area in the County of Waimarino: And whereas it is desirable that the area so added to the County of Waimarino should be included in the Karioi Riding of that county:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred upon me by section twenty-two of the Counties Act, 1908, do hereby declare that the area included as aforesaid in the County of Waimarino shall on and from the first day of May, one thousand nine hundred and eighteen, be included in the Karioi Riding of the said county, and that the boundaries of that riding shall be those set forth in the Schedule hereto.

SCHEDULE.

KARIOI RIDING, WAIMARINO COUNTY.

ALL that area in the Wellington Land District, commencing at the Ruapehu Trig. Station, situated in Block XI, Ruapehu Survey District; thence towards the south-east generally by the south-eastern boundary of Urewera No. 1A Block to the most northern corner of Rangataua North Block; thence by the north-eastern boundary of that block and the north-eastern and south-eastern boundary of Waiakaki Block to the Paumanawera Trig. Station; thence by the northern boundary of Block VI to the right bank of the Mangaehuehu Stream, by that stream to the north-eastern corner of Rangataua Town District, described in *New Zealand Gazette*, 1913, page 1659; thence by the north-eastern and western boundaries of the said town district to the right bank of the Mangaehuehu Stream, and by that stream to the south-eastern corner of Section 5, Block IX, Karioi Survey District; thence towards the south generally by the northern boundaries of Sections 6, 3, 2, 1, of Block IX aforesaid, and the northern boundaries of Sections 4 and 3, Block XII, Makotuku Survey District; thence by the western boundary of Section 3 aforesaid, the southern boundary of Section 2 to the Otirani Road, and by that road in a northerly direction to a point in line with the northern boundary of Section 4, Block XI, Makotuku Survey District; thence to and by that boundary to Hopetaka Creek, and by that creek to the centre of the Mangawhero River; thence towards the west generally by the Mangawhero and Makotuku Rivers to a point in line with the south-western boundary of Section 1, Block VII, Makotuku Survey District; thence to and by the south-western and south-eastern boundaries of the aforesaid section to the abutment of a public road, by that abutment and by the south-eastern boundaries of Sections 25, 24, 23, 22, 21, 20, 19, 17, 16, and P.E.R. 15 of Block III, Makotuku Survey District, the south-eastern boundaries of Sections 12, 11, 10, 9, 8, Horopito Township Reserve, Sections 7, 6, 1, of Block XVI, Manganui Survey District, by part of the north-eastern

boundary of Section 1 aforesaid to the centre of the Ohakune-Motapuna Road; thence by the centre of that road to the Mangaturuturu Stream, and by that stream to a point in line with the eastern boundary of Section 17, Block XII, Manganui Survey District; thence to the southernmost corner of that section and by the eastern boundaries of Sections 17, 14, 12, 8, 6, by a right line to the southernmost corner of Section 18, Block VIII, Manganui Survey District, and by the eastern boundary of the last-mentioned section to the northern boundary of Waimarino County; thence towards the north generally by the county boundary to Ruapehu Trig. Station, the place of commencement: excluding the Borough of Ohakune.

Redefining Boundaries of the Borough of Ohakune and the County of Waimarino.

Department of Internal Affairs,
Wellington, 30th April, 1918.

PURSUANT to the provisions of section 20 of the Municipal Corporations Amendment Act, 1910, the boundaries of the Borough of Ohakune are hereby defined as set out in the First Schedule hereto, the boundaries of the said borough having been altered by an Order in Council dated the 25th day of March, 1918, made under the Municipal Corporations Act, 1908, as amended by the Municipal Corporations Amendment Act, 1913, and published in *Gazette* No. 45, of the 28th day of March, 1918.

And also, in pursuance of the provisions of the said section 20 of the Municipal Corporations Amendment Act, 1910, the boundaries of the County of Waimarino affected by the said Order in Council dated the 25th day of March, 1918, are hereby defined as set out in the Second Schedule hereto.

FIRST SCHEDULE.

BOUNDARIES OF BOROUGH OF OHAKUNE.

ALL that area in the Wellington Land District bounded by a line commencing at the northernmost corner of Section No. 2, Block V, Karioi Survey District; thence along the north-western boundary of that section and across a railway and road reserve to the easternmost corner of Section

No. 9, Block V aforesaid; thence along the north-eastern boundary of the said Section No. 9 for a distance of 3100 links; thence along a right line parallel to the south-eastern boundary of Section No. 9 aforesaid to its south-western boundary-line; thence along the said south-western boundary-line to the northernmost corner of Section No. 10A, Block V aforesaid; thence along the north-western boundary of the said Section No. 10A to the Ohakune-Waiouru Road; thence across that road and along its southern side to the northernmost corner of Section No. 16, Block V aforesaid; thence along the north-western boundary of that section to the north-eastern corner of Section 27, Block VIII, Makotuka Survey District; by the north-eastern and north-western boundaries of the said Section 27 to the northern side of Ratamaire Road; thence by that road to the south-eastern corner of Section 26, Block VIII, Makotuka Survey District; thence along the south-western boundary of that section to and across the Ohakune-Raetihi Road; thence along the north-western side of that road to the easternmost corner of Section No. 2, Block VIII aforesaid; thence along the north-eastern boundaries of Sections Nos. 2 and 4, and along the south-eastern boundary of Section No. 5, Block VIII aforesaid, and that boundary produced to the Mangawhero River; thence across that river to the westernmost corner of Subdivision No. 1 of Raetihi No. 3B Block; thence along the north-western boundary of the said subdivision No. 1, and that boundary produced to the Waimarino Road; thence across the said road to the southernmost corner of Crown land as proclaimed in the *New Zealand Gazette* No. 36, of the 4th May, 1911, page 1447; thence along the south-eastern boundary of the said Crown land to the Main Trunk Railway line; thence across the said railway-line and along its north-eastern side to railway reserve of 53 acres 2 roods, formerly part of Raetihi No. 4B Block; thence along the northern boundary of the said railway reserve and the said northern boundary produced to the south-western boundary of Raetihi No. 5B Block; thence along the last-mentioned boundary to the Mangawhero River; thence across that river and a road reserve to Section No. 3, Block I, Karioi Survey District; thence along part of the north-western boundary of that section to its westernmost corner, and along its southern boundary to a point in line with the north-eastern boundary of Section No. 1, Block V, Karioi Survey District; and thence across a road and along the north-eastern boundary of Section No. 1 aforesaid to the place of commencement.
