2. The following persons shall be and are hereby excluded from the part of the said Wanganui Racecourse Reserve while the same is used or occupied by the said club for a race meeting, namely:—
(a.) Bookmakers.

 (b.) All persons under disqualification inflicted by any racing club in the Dominion of New Zealand, the Commonwealth of Australia, or elsewhere, if affiliated with the Racing Conference or Trotting liated with the Racing Conference or Conference of New Zealand.

(c.) Common prostitutes, and persons who habitually consort with thieves or with persons who have no law-

ful visible means of support.

3. The regulations of the said club made the 1st day of December, 1915, are hereby repealed.
