

All open country in native grass, interspersed with exotic grasses. About 7 acres flat, remainder tableland and terraces. Altitude, sea-level to 1,335 ft. Watered by small creeks and springs. Volcanic soil, all warm safe country. Access from Purau Wharf by formed road one mile and a half, and by unformed road two miles. There is also a boat-landing at Camp Bay.

Amending Regulations for the Military Forces of New Zealand re Military Honours and Military Funerals.

IN pursuance and exercise of the powers and authorities conferred on me by the Defence Act, 1909, and its amendments, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby amend in the manner and to the extent set forth in the Schedule hereto the regulations re military honours and military funerals made on the twentieth day of December, one thousand nine hundred and seventeen, and published in the *New Zealand Gazette* of the same date; and I do hereby declare that such amendments shall take effect as from the twenty-fifth day of March, one thousand nine hundred and eighteen.

SCHEDULE.

SECTION XI.—MILITARY HONOURS AND MILITARY FUNERALS.

PARAGRAPH 556 (b) and (c) are hereby amended by deleting the word "six" in the sixth and third lines respectively, and substituting therefor in each case the word "twelve."
