## SCHEDULE.

*Re TANGIHANGA 1A.*

SOME difficulty has arisen in connection with the administration and distribution of a trust fund of £8,500 created in connection with the above-mentioned block of land, situate in the Poverty Bay District.

The circumstances leading to the creation of the fund were as follows:—

(a.) In or about the year 1887 the Native owners of the Okahuatū No. 1 Block, the Okahuatū No. 2 Block, and the Tangihanga Block, all situated in the District of Poverty Bay, sold those lands, less a small area reserved thereout, and on sale thereof divers of the vendors did bring into a common fund their shares of purchase-money, and did entrust
