Revoking Appointment of Public Trustee as Administrator of an Estate under the Reformatory Institutions Act, 1909.

WHEREAS by section thirty-seven of the Reformatory Institutions Act, 1909, it is enacted that when an Y Institutions Act, 1909, it is enacted that when an order has been made against any person (whether before or after the commencement of that Act) for her detention in an institution, the Public Trustee may be appointed as the administrator or interim curator of her estate, in accordance with Part III of the Prisons Act, 1908, and all the provisions of sections fifty-five to seventy-five of that Act shall, so long as the order of detention remains in force, apply to that person accordingly in the same manner in which those provisions apply to persons imprisoned:
