WHEREAS the land described in the Schedule hereto W HEREAS the land described in the Schedule hereto was, by an order of the Native Land Court made on the fourth day of December, one thousand nine hundred and sixteen, duly laid off as a road-line, in pursuance of sections forty-nine, fifty, and fifty-two of the Native Land Amendment Act, 1913: And whereas the said Court is of the opinion that the said

road-line should be proclaimed as a public road, and a notin-cation to that effect has been forwarded to the Minister of Lands, in terms of section fifty-one of the said'Act: And whereas one month's notice in writing of the intention to proclaim the said road-line as a public road has been given by the Surveyor-General to the local authority of the district concerned, in terms of section fifteen of the Native Land Amendment.Act, 1914: And whereas it is now expedient that the said road-line should be proclaimed as a public road:
