And whereas the Wellington City Council, being the local authority having control of the street described in the Schedule hereto, has passed the following resolution—viz., "The Wellington City Council, being the local authority having control of the streets in the City of Wellington, hereby declares that the provisions of section one hundred and seventeen of the Public Works Act, 1908, shall not apply to Broadway Terrace in the said city":

And whereas it is deemed expedient that such resolution should be approved:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred by the above-in-part-recited Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the said resolution.

ALL that street situated in the Wellington Land District, City of Wellington, known as Broadway Terrace, situated between Webb Street and Arlington Street. As the said street is more particularly delineated on the plan marked P.W.D. 46246, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured red.

Constitution of a Drainage Area under the Swamp Drainage Act, 1915.

ORDER IN COUNCIL.

At the Government House at Wellington, this twenty-sixth day of August, 1919.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS section two of the Swamp Drainage Act, 1915, enacts that the Governor-General may from time to time, by Order in Council gazetted, declare any area of land described in the Order to be a drainage area to which the said Act applies: And whereas it is deemed expedient to declare the area of land described in the Schedule hereto to be a drainage area within the meaning of the said Act:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred in section two of the Swamp Drainage Act, 1915, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby constitute and declare the area described in the Schedule hereto to be a drainage area to which the said Act shall apply, and to be called by the name of the "Hikurangi Drainage Area."

SCHEDULE.

HIKURANGI DRAINAGE AREA.

ALL that area in the North Auckland Land District, situated in Hukerenui, Opuawhanga, and Purua Survey Districts, bounded, commencing at the southernmost corner of Section 9, Block XIII, Hukerenui Survey District, towards the north-west generally by the aforesaid Section 9, the crossing of a public road, by the road forming the north-eastern boundary of the said Section 9, the south-eastern boundary of Section 8A, Block XIII aforesaid, the northern boundaries of Sections 7 and 6, Block XIII aforesaid, the north-western boundary of Section 9, Block XIV, Hukerenui Survey District, and the western boundaries of Sections 6A and 6, Block XIV aforesaid, and by Section 34, Block X, Hukerenui Survey District, to its south-eastern corner; thence by a right line to the westernmost corner of Section 29, Block X aforesaid, by Sections 46, 26, 47, 35, 10A, 31, and 23, Block X aforesaid, the crossing of a public road, by the aforesaid road forming the north-eastern boundaries of Section 23 aforesaid and Section 22, Block X aforesaid, by the road forming part of the eastern boundary of Section 16, Block X aforesaid, and

intersecting Section 17 of the same block, forming the western boundary of Ruapekapeka No. 1G Block, intersecting Ruapekapeka No. 1H Block, forming part of the western boundary of Section 49, Block VI, Hukerenui Survey District, and by the road intersecting the last-mentioned section and Section 50, Block VI aforesaid; towards the north generally by the aforesaid road forming part of the southern boundary of Puhipuhi part No. 4A No. 1 Block, intersecting the same block and again forming its boundary, by the road forming part of the south-western boundary of Section 4, Block VII, Hukerenui Survey District, by Sections 13 and 12 of Block VII aforesaid, by Puhipuhi No. 4B North Nos. 1, 2, 3B, 3A, and 4 Blocks, Puhipuhi No. 5C No. 2; the crossing of a public road, by the road forming the eastern boundary of the last-mentioned block to the northern boundary of Puhipuhi No. 5C No. 3 Block; thence by a right line to the westernmost corner of Section 12, Block VIII, Hukerenui Survey District, by the north-western boundary of Section 12 last mentioned, and that boundary produced to the road intersecting Section 3, Block VIII aforesaid, by that road and its continuation intersecting Sections 2 and 1, Block VIII aforesaid, and Section 21, Block XII, Hukerenui Survey District, and forming the south-eastern boundary of Section 19A, Block XII aforesaid, by the road intersecting Section 19, Block XII aforesaid, and forming part of its south-eastern boundary, forming the south-eastern boundaries of Sections 6, 25, and 26, Block XII aforesaid, Section 20, Block VIII aforesaid, and of Sections W. 27 and E. 27, Block IV, Opuawhanga Survey District, by the road intersecting Sections 12 and 1, Block IV aforesaid, Sections 2 and 4, Block VII, Opuawhanga Survey District, forming part of the south-western boundary of Section 18, Block VII aforesaid, intersecting Crown land, forming the south-eastern boundaries of Sections 31, 30, and 10, the northern boundary of Section 7 and intersecting Section 5, all of Block VII aforesaid, by the road intersecting Sections 10 and 11, Block XII, Hukerenui Survey District aforesaid, intersecting Section 14 and forming the north-western boundary of Section 15, all of Block XII aforesaid, the crossing of the said road, by the road forming the northern boundary of Section 26, intersecting Section 20, Block XII aforesaid, forming part of the south-western boundary of Section 15 aforesaid, the western and southern boundaries of Section 22, and the south-western boundary of Section 1, both of Block XII, Opuawhanga Survey District aforesaid, by the road forming the eastern boundary of Section 9, Block XVI, Hukerenui Survey District, intersecting Tauranga Block, forming the north-eastern boundaries of Sections 5, 6A, 6, and 7, Block XVI aforesaid, intersecting Allotment N.E. 49, Hikurangi Parish, and the road forming the southern boundaries of the last-mentioned allotment and Allotments S.W. 49, N.E. and S.W. 47, and part of 45, Hikurangi Parish aforesaid, the crossing of the said road, by Allotments N.E. 53, S.W. 55, the crossing of a road, by Allotments W. 56 and E. 56, by the road forming the eastern boundary of Allotment 57, the crossing of the said road, by Allotment S. 59, by the road forming the eastern boundaries of Allotments 60 and 61, all the last-mentioned allotments being of Hikurangi Parish aforesaid; towards the south-east generally by Allotment 38, Whangarei Parish, by the road forming the south-western boundaries of Allotments 36, 35, 31, and part of 30, Whangarei Parish aforesaid, by the crossing of the said road, by Allotments 32 and 33, Whangarei Parish aforesaid, by part of the road forming the north-eastern boundary of Allotment 25, Whangarei Parish aforesaid, the crossing of the said road, by the last-mentioned Allotment 25, by Te Roro Block, by the road intersecting Waihirere Block, Section 1, Block IV, Purua Survey District, Section 18, Block VII, Purua Survey District aforesaid, and the Maketawa, Tamahia, Ngararatuhua, Whakaparapara, and Waipapa Blocks, by the road forming the southern boundary of Allotment 143, Ruatangata Parish, the southern and south-western boundary of Allotment 12, the south-western boundaries of Allotments 13 and 14, by Allotments 15, 24, and 25, by part of the road forming the south-western boundary of Allotment 26, by the road forming the southern boundaries of Allotments 135, 134, 133, and 132, by the same road forming the south-eastern boundary of Allotment 34, the crossing of a road, by Allotments 36A and 50A, the crossing of a road, by the road forming the south-eastern boundaries of Allotments 59 and 60, and part of the south-western boundary of the last-mentioned allotment, by the crossing of the said road, by the road forming the south-eastern boundary of Allotment 63, by Allotment 62, by the road forming part of the north-western boundary of Allotment 89, by the road forming the south-western boundary of the last-mentioned allotment, and by the road forming the north-western boundaries of Allotments 98 and 99, all the last-mentioned allotments being of Ruatangata Parish aforesaid; and towards the west generally by the road forming the north-eastern boundaries of Allotments 125 and 120, Ruatangata
