#### A PROCLAMATION.

WHEREAS the land described in the Schedule hereto forms part of land taken for the purposes of the Stratford Main Trunk Railway (Matiere Section), and it is considered desirable to allocate such land to the purposes of a road:

And whereas it has been certified by the Minister of Public Works that such land is not required for railway purposes: And whereas such land is situated in the Ohura County, the local authority of which has consented to the issue of this Proclamation, and appears to be the local authority most capable of conveniently and effectively controlling and maintaining the said road:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities vested in me by section one hundred and ninety-seven of the Public Works Act, 1908, and of every other

power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto shall, upon the publication hereof in the *New Zealand Gazette*, become a road, and that the said road shall be maintained by the Ohura County Council in like manner as other public highways are controlled and maintained by the said Council.
