Opening National Endowment Lands in North Auckland Land District for Selection by Discharged Soldiers on Renewable Lease.

IN pursuance and exercise of the powers and authorities conferred upon me by the Land Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby declare that the national endowment lands described in the Schedule hereto, which have been set apart for selection by discharged soldiers, shall be open for selection by discharged soldiers on renewable lease on Monday, the seventeenth day of November, one thousand nine hundred and nineteen, at the rentals mentioned in the said Schedule; and I do also declare that the said lands shall be leased under and subject to the provisions of the said Act and the Discharged Soldiers Settlement Act, 1915.

SCHEDULE.

NORTH AUCKLAND LAND DISTRICT.—FIRST-CLASS LAND.—NATIONAL ENDOWMENT.

Waitemata County.—Paremoremo Parish.

SECTION 286: Area, 87 acres 2 roods 14 perches; capital value, £350; half-yearly rent, £7.

SECTION 287: Area, 49 acres 0 roods 28 perches; capital value, £200; half-yearly rent, £4.

Altitude, 40 ft. to 200 ft. above sea-level. Undulating fern and manuka country, three-quarters ploughable. Soil, brown loam of medium quality, on clay subsoil.
