The following are the regulations referred to :---

KUROW JOCKEY CLUB.

REGULATIONS.

(Under the Gaming Act, 1908.)

In pursuance and exercise of the powers in that behalf con-In pursuance and exercise of the powers in that behalf con-tained in section 33 of the Gaming Act, 1908, and of all other powers and authorities it enabling in that behalf, the Kurow Jockey Club, a racing club within the meaning of the said Act (hereinafter referred to as "the said club"), doth hereby revoke the regulations dated the 16th day of November, 1915, and in lieu thereof doth hereby make the following regulations controlling the admission of pursons to that part of the Kurow and in lieu thereof doth hereby make the following regulations controlling the admission of persons to that part of the Kurow Racecourse situated in the district of Waitaki, and known as the Kurow Racecourse, while the said racecourse is used or occupied by the said club for race meetings. 1.  (d.) Common prostitutes, and persons who habitually consort with thieves or with persons who have no lawful visible means of support.
 (e.) Professional tipsters, persons convicted of house-breaking or pocket-picking, forgery, uttering or possessing counterfeit coin, theft, false pretences, receiving stolen goods, mischief, assault, or any offence or crime of any kind under the Crimes Act, 1908; and also idle and disorderly persons, rogues and vagabands, and incorrigible rogues convicted and vagabonds, and incorrigible rogues convicted under the Police Offences Act, 1908, and persons convicted of an offence under the Gaming Act, 1908.
