DESCRIPTION.

Sections 19 and 43, Block I, front on Orchard Road, about Sections 20 and 43, Block 1, front on Orenara Road, about two miles from Ngatea. All peat of fair quality, varying in depth from 2 ft. 6 in. to 7 ft. Covered with growth of wiwi, fern, and manuka.
