# LIVERPOOL, Governor-General, A PROCLAMATION

HEREAS by Proclamation dated the fourth day of May, one thousand nine hundred and sixteen, and published in the New Zealand Gazette of the eleventh day of that month, the land described in the Schedule hereto was declared to be a reserve under the Scenery Preservation Act,

And whereas the said land is no longer suitable for scenic

purposes owing to the absence of scenic bush thereon:
Now, therefore, I, Arthur William de Brito Savile, Earl
