At the Government House at Wellington, this third day of November, 1919.

### Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS it is provided by section forty-two of the Harbours Amendment Act, 1910 (hereinafter called 'the said Act''), that the Governor-General may from time to time by Order in Council authorize any local authority to reclaim areas not exceeding five acres in extent, in any case where he considers that the reclamation will not affect navi-gation and is for the benefit of the public, and in such case it shall not be necessary to obtain a special Act:

And whereas the Wellington City Council desires to reclaim an area of less than five acres in extent in Oriental Bay, Wellington Harbour, and the Wellington Harbour Board has

agreed to such reclamation:

And whereas it has been made to appear to the Governor-General in Council that the proposed work will not be or

tend to the injury of navigation:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in exercise of the power conferred upon him by the said Act, and acting by and with the advice and consent of the Executive Council of the said the advice and consent of the Executive Council of the said Dominion, doth hereby authorize the Wellington City Council to reclaim the area in Oriental Bay, Wellington Harbour, which is shown in red on plan marked M.D. 5100, and deposited in the office of the Marine Department at Wellington, such area being marked on the plan "Area, 28.02 perches."
