*Constituting the Southland Electric-power District.*[L.S.] LIVERPOOL, Governor-General.  
A PROCLAMATION.

WHEREAS it is provided by section three of the Electric-power Boards Act, 1918, that any area or areas of land may be constituted an electric-power district or outer area of such district under the said Act, and in the manner therein provided:

And whereas a petition praying that the area described in Part I of the First Schedule hereto may be constituted an electric-power district under the said Act, and that the area described in the Third Schedule hereto may be constituted an outer area of such electric-power district, and also a further petition praying that the boundaries of the proposed electric-power district be altered so as to include the area described in Part II of the First Schedule hereto, were presented to the Governor-General on the fifth day of November, one thousand nine hundred and nineteen:

And whereas such petitions were publicly notified in the *Southland Times* dated the eighteenth day of September, one thousand nine hundred and nineteen, and the *Tapanui Courier* dated the twenty-fourth day of September, one thousand nine hundred and nineteen, respectively, being newspapers circulating in the proposed electric-power district:

And whereas after due inquiry the Governor-General is of opinion that the petitions should be granted subject to the proposed boundaries of the district being altered as hereinafter appears:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon me by section three of the Electric-power Boards Act, 1918, do hereby alter the proposed boundaries and proclaim the district with the altered boundaries as described in the Second Schedule hereto to be an electric-power district, and I hereby assign to such district the name of the "Southland Electric-power District"; and I do further proclaim that the area described in the Third Schedule hereto shall be an outer area of such electric-power district.

## FIRST SCHEDULE.

## PART I.

THE areas comprised within the boundaries of the Counties of Southland and Wallace, inclusive of the Boroughs of Invercargill, South Invercargill, Gore, Riverton, Winton, Mataura, and Bluff, and the Town Districts of Wyndham, Otautau, Lumsden, Edendale, and Nightcaps.

## PART II.

All that area bounded as follows: Commencing at the junction of the Southland and Clutha Counties at the Leithen Burn, in the Greenvale Survey District; thence follow that burn west and south to the Pomahaka River; thence north along the Pomahaka River to the north-west corner of Section 34 of Block VI of said district; thence east along the northern boundary of said Section 34; thence north along the western boundaries of Sections 34, 23, 26, and 27 of the Moa Flat Estate to the most northerly point of said Section 27; thence in a south-easterly direction along the boundary between Sections 27 and 28 of said estate to the Moa Flat - Ettrick Road; thence following that road south-west to the north-western corner of Section 16 of said estate; thence eastward and north-eastward along the boundary-line between Sections 1, 2, and 3 on the northern side and Sections 16, 15, 14, and 4 of said estate on the southern side to the Lawrence - Roxburgh Road; thence south-east to the north-eastern boundary of Section 5 of said estate; thence west and south along the boundary between Sections 4 and 5 of said estate; thence north-east along the boundary between Sections 7 and 5 of said estate; thence south along the boundary between Sections 7 and 6 and between Sections 8 and 6 of said estate to the most northerly point of Section 8, Block XVII, Crookston Survey District; thence following the boundary of Block XVII, Crookston Survey District, first south-east, thence due east, thence due south to the south-eastern corner of Section 12, Block XVII of said district; thence west along the south boundary of Sections 12 and 13 of said Block XVII to the north-eastern corner of Section 3, Block XIII, Crookston Survey District; thence due south following the east boundary of Blocks XIII

and XIV of said district to the Trig. Station L; thence from such trig. station in a south-westerly direction along the boundaries of Block XIV and Sections 5, 3, and 2, Block XI, to the north-western corner of Section 1, Block X, Crookston Survey District; thence south and south-west along the most easterly boundaries of Sections 1 and 2, Block X, Crookston Survey District, and Section 1, Block V, Crookston Survey District, to the boundary between the Crookston and Rankleburn Survey Districts; thence along the south-eastern boundary of Section 5, the north-eastern boundary of Sections 20, 24, 25, 16, 17, and 18, Block IX, Rankleburn Survey District, to the boundary between the Glenkenich and Rankleburn Survey Districts; thence in a southerly direction along the boundary between such last-mentioned survey districts till it joins the Pomahaka River; thence westward along that river to the eastern boundary of Block VIII, Waipahi Survey District; thence due south along the eastern boundary of Blocks VIII and VII, Waipahi Survey District; thence along the southern boundary of Blocks VII and XVIII to the Waipahi River; thence north-easterly along that river to the southern boundary of Block X; and thence along the southern boundary of said Block X, Waipahi Survey District, to the Southland County boundary; and thence northerly along the eastern boundary of the Southland County to the commencing-point.

#### SECOND SCHEDULE.

##### SOUTHLAND ELECTRIC-POWER DISTRICT.

ALL that area bounded as follows: Commencing at Sandhill Point, the south-west corner of Wallace County, thence running in a northerly direction along the western boundary of Wallace County as defined in *New Zealand Gazette*, 1897, Vol. I, page 341, to George Sound; thence by sea to Bligh Sound; thence in an easterly direction along the northern boundary of Wallace County and Southland County, as defined in *New Zealand Gazette*, 1917, Vol. II, page 2069, until it reaches the north-west corner of Tuapeka County; thence in a southerly direction along the eastern boundary of Southland County to the junction of the Southland and Clutha Counties at the Leithen Burn in the Greenvale Survey District; thence following that burn west and south to the Pomahaka River; thence north along the Pomahaka River to the north-west corner of Section 34 of Block VI of said district; thence east along the northern boundary of said Section 34; thence north along the western boundaries of Sections 34, 23, 26, and 27 of the Moa Flat Estate to the most northerly point of said Section 27; thence in a south-easterly direction along the boundary between Sections 27 and 28 of said estate to the Moa Flat - Etrick Road; thence following that road south-west to the north-western corner of Section 16 of said estate; thence eastward and north-eastward along the boundary-line between Sections 1, 2, and 3 on the northern side and Sections 16, 15, 14, and 4 of said estate on the southern side to the Lawrence-Roxburgh Road; thence south-east to the north-western boundary of Section 5 of said estate; thence west and south along the boundary between Sections 4 and 5 of said estate; thence north-east along the boundary between Sections 7 and 5 of said estate; thence south along the boundary between Sections 7 and 6 and between Sections 8 and 6 of said estate to the most northerly point of Section 8, Block XVII, Crookston Survey District; thence following the boundary of Block XVII, Crookston Survey District, first south-east, thence due east, thence due south to the south-eastern corner of Section 12, Block XVII, of said district; thence west along the south boundary of Sections 12 and 13 of said Block XVII to the north-eastern corner of Section 3, Block XIII, Crookston Survey District; thence due south following the east boundary of Blocks XIII and XIV of said district to the Trig. Station L; thence from such trig. station in a south-westerly direction along the boundaries of Block XIV and Sections 5, 3, and 2, Block XI, to the north-eastern corner of Section 1, Block X, Crookston Survey District; thence south and south-west along the most easterly boundaries of Sections 1 and 2, Block X, Crookston Survey District, and Section 1, Block V, Crookston Survey District, to the boundary between the Crookston and Rankleburn Survey Districts; thence along the south-eastern boundary of Section 5, the north-eastern boundary of Section 20, and the south-eastern boundary of Sections 20, 24, 25, 16, 17, and 18, Block IX, Rankleburn Survey District, to the boundary between the Glenkenich and Rankleburn Survey Districts; thence in a southerly direction along the boundary between such last-mentioned survey districts till it joins the Pomahaka River; thence westward along that river to the eastern boundary of Block VIII, Waipahi Survey District; thence due south along the eastern boundary of Blocks VIII and VII, Waipahi Survey District; thence along the southern boundary of Blocks VII and XVIII to the Waipahi River; thence north-easterly along that river to the

southern boundary of Block X; and thence along the southern boundary of said Block X, Waipahi Survey District, to the Southland County boundary; and thence in a southerly direction along the eastern boundary of the said Southland County until it reaches the ocean at Chaseland's Mistake; thence in a westerly direction along the coast-line to the commencing-point: including therein the Boroughs of Invercargill, South Invercargill, Bluff, Riverton, Winton, Matura, Gore, Tapanui, and the Town Districts of Otautau, Wyndham, Edendale, Lumsden, Nightcaps.

In the Southland and Otago Land Districts; as the same is more particularly delineated on plan marked P.W.D. 47401, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured in blue as to the electric-power district, and in red as to the outer area.

#### THIRD SCHEDULE.

ALL that area comprised within the boundaries of the County of Fiord.

Given under the hand of His Excellency the Right Honourable Arthur William de Brito Savile, Earl of Liverpool, Member of His Majesty's Most Honourable Privy Council, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Most Excellent Order of the British Empire, Member of the Royal Victorian Order, Knight of Justice of the Order of Saint John of Jerusalem, Governor-General and Commander-in-Chief in and over His Majesty's Dominion of New Zealand and its Dependencies; and issued under the Seal of the said Dominion, at the Government House at Wellington, this fourteenth day of November, in the year of our Lord one thousand nine hundred and nineteen.

*Regulations as to Elections in Combined Districts under the Electric-power Boards Act, 1918.*

LIVERPOOL, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this seventeenth day of November, 1919.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the power and authority conferred upon him by the Electric-power Boards Act, 1918, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations as to the election of members of Electric-power Boards in combined districts.

#### REGULATIONS.

(1.) SUBJECT to the express provisions of these regulations, the election of representatives of a combined district shall be held under the provisions of the Local Elections and Polls Act, 1908, and that Act shall apply accordingly as if such combined district were a district within the meaning thereof.

(2.) Every candidate at any such election of representatives of a combined district shall at the time of his nomination deposit the sum of £3 with the Returning Officer; and if that candidate does not receive one-eighth of the votes received by the successful candidate or, as the case may be, by the successful candidate receiving the fewest votes, the deposit shall be forfeited to the principal local authority of the combined district, and applied towards the cost of the election; but otherwise, or if the candidate duly withdraws his nomination before the election, or is elected without a poll, the deposit shall be returned to him.

(3.) The Returning Officer of each principal local authority of a combined district, or, where there is more than one Returning Officer, the Returning Officer for the subdivision of the district in which or nearest to which the public office of that local authority is situated, shall be the Returning Officer for the election of representatives of the combined district.

(4.) The several electors rolls of the constituent districts included in the combined district shall together be the electoral roll for the purposes of the election of representatives

of such combined districts; provided that every elector on such rolls shall have only one vote at the election.

(5.) The local authority of each constituent district in a combined district shall, on or before the day fixed for nominations, supply the Returning Officer with as many copies of the electors roll of its district as may be required for the purposes of the election.

(6.) In the case of any constituent district comprising only part of a borough, county, town district, or road district, the Clerk of any such borough, county, town district, or road district shall prepare from the existing roll thereof a list of the electors whose qualifications as such arise within or relate to the part of the borough, county, town district, or road district forming the constituent district, and such list of electors when certified by the Clerk preparing the same shall form and be the electors roll for such constituent district; and it shall be the duty of the Clerk preparing any such roll to supply to the Returning Officer, on or before the day fixed for nominations, as many copies of such roll as he may require for the purposes of the election, and the cost of preparing such separate roll shall be part of the cost of the election.

(7.) The cost of any election within a combined district shall be borne and paid by the several local authorities of the constituent districts included in such combined district in the proportion which the unimproved value of the constituent district bears to the total unimproved value of the combined district.

(8.) The Returning Officer shall provide such polling-booths throughout the combined district as he considers necessary, and shall appoint as many Deputy Returning Officers and poll-clerks as are required for the effective taking of the poll at every such polling-booth.

(9.) The poll shall close throughout the combined district at the hour at which it closes for an election in the district of the principal local authority.

(10.) As soon as conveniently may be after ascertaining the result of any election, the Returning Officer therefor shall notify the Minister of Public Works of the result.

ORDER IN COUNCIL.

At the Government House at Wellington, this seventeenth day of November, 1919.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS, in pursuance of the powers vested in the Governor-General by section three of the Electric-power Boards Act, 1918, the Southland Electric-power District was duly constituted by Proclamation dated the fourteenth day of November, one thousand nine hundred and nineteen :

And whereas section ten of the said Act provides that the first election of representatives of any constituent district or combined district in any electric-power district shall be held on such day as the Governor-General by Order in Council appoints :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred upon him by the said Act, doth hereby appoint Saturday, the twentieth day of December, one thousand nine hundred and nineteen, as the day on which shall be held the first election of representatives of the constituent districts and combined districts in the said Southland Electric-power District.

*Apportionment of Representation on Southland Electric-power Board.*

ORDER IN COUNCIL.

At the Government House at Wellington, this seventeenth day of November, 1919.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS, in pursuance of the powers vested in the Governor-General by the Electric-power Boards Act, 1918, a Proclamation was issued on the fourteenth day of November, one thousand nine hundred and nineteen, constituting the Southland Electric-power District to be a district under and for the purposes of the said Act :

And whereas the said Act requires that the number of representatives of each constituent district in the said district shall be such as is determined from time to time in each case by the Governor-General by Order in Council :

And whereas, in the opinion of the Governor-General in Council, it is expedient to combine certain of the said constituent districts into combined districts, and to determine the number of members to be elected in common as the representative of each such combined district :

And whereas the said Act further requires that the Governor-General shall, by Order in Council, from time to time select and appoint one of the local authorities of any combined district to be the principal local authority of that combined district within the meaning and for the purposes of the said Act :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred upon him by the said Act, doth hereby determine with respect to the Southland Electric-power District as follows :—

(1.) The constituent districts which are bracketed together in the first column of the Schedule hereto are hereby constituted combined districts for the purpose of the said Act.

(2.) The local authority of each constituent district distinguished in the first column of the Schedule hereto by the letter "p" is hereby declared to be the principal local authority of the combined district in which that constituent district is included.

(3.) The number of representatives of each constituent or combined district on the Board of the said district shall be the number specified in the second column of the Schedule hereto opposite the name of that constituent or combined district.
