HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by section forty-six of the Customs Act, 1913, as extended by section two of the Regulation of Trade and Commerce Amendment Act, 1915, it is enacted that the Governor-General may by Order in Council prohibit the importation into New Zealand of any goods the prohibition of the importation of which is in his opinion necessary in the public interest:

And whereas by Order in Council dated the tenth day of April, one thousand nine hundred and seventeen, His Ex-cellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred on him as aforesaid, did prohibit, to the extent appearing in the said Order in Council, the importation of goods manu-factured or produced in or exported from enemy territory as therein defined, including territory then in the occupation of the enemy:

And whereas, in the opinion of the Governor-General, it is necessary in the public interest that the said Order in Council should be revoked, so far as it affects territory then in the
