WHEREAS, in accordance with the provisions of section three of the Land Drainage Act, 1908, a majority of the ratepayers in the area described in the First Schedule hereto, situated in the County of Waikato, have presented a petition to His Excellency the Governor-General of the Dominion of New Zealand, praying that the land comprised in the said area be included in the Mangawara Drainage District as constituted under the provisions of the said Act :

And whereas it is expedient to alter the boundaries of such drainage district in manner hereinafter appearing :

Now, therefore, in pursuance and exercise of the power and authority contained in section three of the Land Drainage Act, 1908, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby alter the boundaries of the said Mangawara Drainage District, by including in such district the area of land described in the said petition and in the First Schedule hereto; and doth hereby declare that the boundaries of the said drainage district, with such addition as herein provided for, shall be those described in the Second Schedule hereto.

FIRST SCHEDULE.

AREA TO BE INCLUDED IN THE MANGAWARA DRAINAGE
DISTRICT.

ALL that area in the Auckland Land District bounded towards the north generally by the Waikari Lake from the north-eastern corner of Section 366, Block V, Hapukohu Survey District, to the northernmost corner of Section 191, Block V
