Regulations for Deer-shooting, Southland.

# LIVERPOOL, Governor-General.

IN exercise of the powers vested in me by the Animals Protection Act, 1908 (hereinafter called "the said Act"), I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zesland, do hereby make the following regulations prescribing the deer-shooting season in the Southland Acclimatization District, excluding Stewart Island and all sanctuaries, and the conditions affecting the same, and also the form of license and the fee payable therefor.

### REGULATIONS.

1. Red deer (stags only) may be taken or killed within the Southland Acclimatization District, excluding Stewart Island and all sanctuaries, from the 1st day of April. 1919, to the

31st day of May, 1919, both days inclusive.

2. Licenses to take or kill such deer may be issued by the Chief Postmaster at Invercargill, on payment of a license fee of £4 4s., in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations. The number of such licenses shall not exceed ten; provided that not more than one such license shall be issued to the same person.

3. No licensee shall take or kill more than two stags, and no stag shall be killed carrying antlers with less than ten

4. No hind or fawn shall be taken or killed on any pretext whatever; and no licensee shall allow any dog to accompany either himself or any attendant he may have with him.

5. Nothing herein contained shall extend to authorizing

any person to sell any deer or portion thereof.
6. Regulations as to deer "tags," per New Zealand Gazette
No. 40, Vol. I, of 20th May, 1909, page 1408, shall be strictly adhered to by each licensee, who, in addition thereto, shall return all unused "tags" to the secretary of the Southland Acclimatization Society, Invercargill, immediately he has finished stalking for the season for which such "tags" have been issued, together with a statement of the number of deer

7. Any person committing a breach of any of these regulations shall be liable, on conviction, to a fine not exceeding £20.

#### REGULATIONS.

1. Red-deer stags may be taken or killed within the above-mentioned part of the Rotorua Acclimatization District from the 26th March, 1919, to the 26th April, 1919 (both

days inclusive).

2. Licenses to take or kill such deer may be issued by the Postmistress at Waikaremoana, on payment of a license fee of £3, in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations. The number of such licenses shall not exceed ten; provided that not more than one such license shall be issued to the same

3. No licensee shall take or kill more than two stags, and no stag shall be killed carrying antlers with less than ten

4. Each licensee must give notice to the said Postmistress of the date on which it is his intention to stalk, such notice to be given, in writing or by telegraph, two clear days before commencing to stalk.

5. No hind or fawn shall be taken or killed on any pretext whatever; and no licensee shall allow any dog to accompany either himself or any attendant he may have

6. Nothing herein contained shall extend to authorizing

6. Nothing herein contained shall extend to authorizing any person to sell any deer or portion thereof.
7. Regulations as to deer "tags," per New Zealand Gazette No. 40, Vol. I, of 20th May, 1909, page 1408, shall be strictly adhered to by each licensee, who, in addition thereto, shall return all unused "tags" to the Postmistress at Waikaremoana immediately he has finished stalking for the season for which such "tags" have been issued, together with the advice of number of deer shot. of number of deer shot.

8. Any person committing a breach of any of these regulations shall be liable, on conviction, to a fine not less than £5 nor exceeding £20.
