Notice to make Returns of Land under the Land and Income Tax Act, 1916.

Land and Income Tax Department, Wellington, 27th March, 1919.

OTICE is hereby given that, in pursuance of the above Act and the regulations made thereunder, every person and company within the meaning of the said Act, being owner of land in New Zealand, is hereby required to make and furnish to me, in the prescribed form, returns of such land as at 12 o'clock noon on the 31st day of March, 1919.

And, further, notice is hereby given that such returns shall in all cases be delivered at or forwarded to the office of the Commissioner of Taxes, in the Government Buildings at Wellington, on or before the 8th day of April, 1919.

Note.—Forms of return may be obtained at any postal money-order office; they will not be sent to taxpayers from the office of the Commissioner of Taxes unless written application is made for them.

If the total unimproved value of the land of a taxpayer, as assessed under the Valuation of Land Act, 1908, does not "Owner of land" includes a lessee of land owned by

Natives.

SPECIAL NOTE.—Any person tailing to furnish a return at the prescribed time is liable to a penalty up to £100.
