specified in the Order, cease to be subject to the Kauri-gum Industry Act, 1908, and on and after the date so specified the land to which the Order relates shall become subject to the provisions of the Land Act, 1908:

And whereas the Land Board of the Auckland Land District has duly passed a resolution recommending that the portion of the Opoe Kauri-gum Reserve Extension No. 2 described in the Schedule hereto be excepted from the operations of the Kauri-gum Industry Act, 1908, and it is

expedient to give effect to such recommendation:

Now, therefore, I, Arthur William de Brito Savile, Earl of
Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and autho rity conferred upon me by section forty-six of the Land Laws Amendment Act, 1913, and acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby order and declare that the portion of the Opoe Kauri-gum Reserve Extension No. 2 described in the Schedule hereto shall, from the twenty-fourth day of April, one thousand nine hundred and nineteen, cease to be subject to the Kauri-gum Industry Act, 1908.
