

## NOTICE OF INTENTION TO TAKE LAND.

## COPY OF RESOLUTION.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Waitotara County Council hereby resolves as follows:—

That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of £1,150 (eleven hundred and fifty pounds), authorized to be raised by the Waitotara County Council, under the Local Bodies' Loans Act, 1913, for the purpose of metalling 98 chains of the Tokomaru West Road, to be called the Tokomaru West Road Special Loan of £1,150, the said Waitotara County Council hereby makes and levies a special rate of seven-sixteenths of a penny in the pound upon the rateable value of all rateable property in the Tokomaru West Road Special Rating District, comprising Lots 1, 2, 3, and part of 5, 6, 7, and 8, Kaiwhatu and Ruahine Blocks, D.P. 396, Blocks VIII and XII, Waipakura Survey District, and Block IX, Nukumaruru Survey District; Lot 4, Kaiwhatu Block, D.P. 396, Block VIII, Nukumaruru Survey District; part of Lot 5, Kaiwhatu Block, D.P. 396, Block VIII, Nukumaruru Survey District; part Section 5, Ruahine Block, Block VIII, Nukumaruru Survey District; Sections 26A, 26B, 27A, 27B, Block VIII, Nukumaruru Survey District; containing a total area of 4,911 acres in the Nukumaruru Survey District. And that such rate shall be an annually recurring rate during the currency of such loan, and shall be payable

yearly on the first day of September in each and every year during the currency of such loan, being a period of 36½ years, or until the loan is fully paid off.
