HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by section forty of the Public Reserves and Domains Act, 1908 (hereinafter termed "the

said Act"), it is enacted that the Governor-General may from time to time, with respect to any public domain, appoint such persons (not exceeding nine) as he thinks fit to be a Domain Board having, subject to Part II of the said Act, control of such domain :

And whereas by an Order in Council made on the twenty-first day of May, one thousand nine hundred and twelve, and published in the *New Zealand Gazette* of the thirtieth day of May, one thousand nine hundred and twelve, a Domain Board was appointed to control the Ranfurly Domain :
