ORDER IN COUNCIL.

At the Government House at Wellington, this seventeenth day of June, 1919.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

IN pursuance and exercise of the powers vested in him by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the portion of road described in the Schedule hereto shall, on and after the date of this Order in Council, become a county road.

SCHEDULE.

ALL that portion of the Marakopa River to Mahoenui Road, in the Auckland Land District, Awakino County, commencing at the south-eastern corner of Section 8, Block VI, Maungamangero Survey District, and running generally in a north-westerly direction, adjoining or passing through the said Section 8, and terminating at its junction with Mangaotaki Valley (Upper) Road; being a distance of twelve chains, more or less. As the said portion of road is more particularly delineated on the plan marked P.W.D. 46184, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured red.
