TN pursuance and exercise of the powers conferred on me by section one hundred and forty-four of the Land Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby resume possession of the land described in the Schedule hereto, the said land being in my opinion required for forestry purposes.

SCHEDULE.

ALL that land in the Auckland Land District, containing 386 acres, more or less, and being Section 27, Block X, Waipoua Survey District.

Given under the hand of His Excellency the Right Honourable Arthur William de Brito Savile, Earl of Liverpool, Member of His Majesty's Most Honourable Privy Council, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Grand Cross of the Most Excellent Order of the British Empire, Member of the Royal Victorian Order, Knight of Grace of the Order of Saint John of Jerusalem, Governor-General and Commander-in-Chief in and over His Majesty's Dominion of New Zealand and its Dependencies; and issued under the Seal of the said Dominion, at the Government House at Wellington, this twenty-eighth day of January, in the year of our Lord one thousand nine hundred and nineteen.

Additional Regulations as to the Votes of Members of the New Zealand Expeditionary Forces for the Purposes of the Special Licensing Poll to be taken under the Licensing Amendment Act, 1918.

LIVERPOOL, Governor-General. ORDER IN COUNCIL

At the Government Buildings at Wellington, this twenty-eighth day of January, 1919.

THE HONOURABLE SIR JAMES ALLEN, K.C.B., PRESIDING IN COUNCIL.

HEREAS by Order in Council dated the nineteenth W day of December, one thousand nine hundred and eighteen, regulations were made with respect to the taking and recording of the votes of members of the New Zealand Expeditionary Forces for the purposes of the special licensing poll to be taken pursuant to the Licensing Amendment Act 1018. Act, 1918:

And whereas it is necessary to extend the said regulations in the manner and to the extent set forth in the Schedule hereto:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise the Dominion of New Zealand, in pursuance and exercise of the powers conferred on him by section twelve of the Licensing Amendment Act, 1918, and acting by and with the advice and consent of the Executive Council of that Dominion, doth hereby amend the hereinbefore-recited regu-lations of the nineteenth day of December, one thousand nine hundred and eighteen, by inserting after clause thirteen thereof the now clause out in the Schedule herets the new clause set out in the Schedule hereto.

Additional Regulations as to Votes by Soldiers on SHIPS.

13A. (1.) IF the High Commissioner has knowledge that any vessel (other than a vessel to which clause 13 of the regu

lations of the 19th December, 1918, applies) is about to leave any port of Europe, Asia, or Egypt for New Zealand, with members of a New Zealand Expeditionary Force on board, after the 14th day of February, 1919, and before the 10th day of April, 1919 (being the day appointed for the taking of the special licensing poll), the High Commissioner shall himself cause to be supplied, to the military officer in charge a ballot-box or ballot-boxes, together with a sufficient number of voting-papers for the taking of the votes of the members of the Expeditionary Forces on board such vessel.
(a) The said military officer shall also cause to be delivered to the Chief Electoral Officer in a sealed parcel all documents used in connection with the poll, and all unused and spoilt voting-papers.
(b) The said military officer in charge a ballot-box
(c) The said military officer abell on the day appointed

(2.) The said military officer shall, on the day appointed (2.) The said ministry oncer shall, on the day appointed for the taking of the special licensing poll, cause a poll to be taken of all men on the vessel entitled to vote, and shall not count the votes, but shall forthwith after the close of the poll securely seal the ballot-box or ballot-boxes, and shall deliver the same or cause the same to be delivered, to the Chief Electoral Officer in Wellington, or to a person

shall cause the votes to be counted, and shall transmit to the Minister of Justice the particulars required pursuant to section thirteen of the said Act. (5.) Clauses fourteen to twenty, inclusive, of the herein-before-recited regulations of the nineteenth day of December, 1918, shall apply to all polls to be taken pursuant to this clause in the same manner in all respects as if this clause had here included in the scied acculations. had been included in the said regulations.
