[L.S.] LIVERPOOL, Governor-General: A PROCLAMATION.

WHEREAS by section fourteen of the Native Land Amendment Act, 1914, it is provided, *inter alia*, that on being satisfied that the purchase of any Native land has been duly completed by or on behalf of the Crown under the authority of the Native Land Act, 1909, the Governor-General may issue a Proclamation that such land has become Crown land :

And whereas the purchase of the Native land set out in the Schedule hereto has been duly completed by or on behalf of the Crown under the authority of the Native Land Act, 1909:

Act, 1909: Now, therefore, in pursuance and exercise of the power and authority so conferred upon me by section fourteen of the Native Land Amendment Act, 1914, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-Genèral of the Dominion of New Zealand, do hereby proclaim the land set out in the Schedule hereto to be Crown land.

PAOBA Aneti No. 1A Block, Section 37, Block V: Approximate area, 31 acres 0 roods 31 perches; Cape Survey District.
