A PROCLAMATION.

WHEREAS by section sixty-three of the Land Laws Amendment Act, 1913, it is, amongst other things, enacted that in no case shall any moneys be expended under the provisions of the said section sixty-three in connection with any block of land, unless that block is set apart for selection under that section pursuant to Proclamation in that behalf:

Now, therefore, in pursuance and exercise of every power and authority enabling me in this behalf, and for the purposes of the aforesaid Act, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, do hereby proclaim the land described in the Schedule hereto as set apart for selection.

HAWKE'S BAY LAND DISTRICT.
Tahoraite Extension Block.

SECTION 6, Block VI, Tahoraite Survey District: Area, 123 acres.

As the same is delineated upon the plan marked L. and S. 5/124, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon edged red.

A PROCLAMATION.

WHEREAS the lands described in the first column of the Schedule hereto were by Warrants, the dates of which are specified in the second column of the said Schedule, and the notifications of which were published in the *Gazettes* specified in the third column, permanently set apart as reserves for scenic purposes under the provisions of the Land Act, 1892: And whereas it is expedient that the said lands should be declared reserves under the Scenery Preservation Act, 1908:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers conferred by section twelve of the Scenery Preservation Amendment Act, 1910, do hereby proclaim and declare that the lands described in the first column of the Schedule hereto shall, from and after the date hereof, be scenic reserves under the Scenery Preservation Act, 1908, and its amendments.
