A PROCLAMATION.

WHEREAS by section five of the Land Act, 1908, it is therein provided that every Proclamation, Order in Council, and other instrument (whether made under or by virtue of that Act or of any former Land Act), and all regulations, by-laws, conditions, or rules made by the Governor-General, the Minister, or any Land Board, may be altered, amended, or revoked from time to time:

And whereas it is necessary to alter or amend a Proclamation issued under the said Act proclaiming land as a road and closing a road in Block I, Teviotdale Survey District, dated the twenty-ninth day of December, one thousand nine hundred and fifteen, and published in the *New Zealand Gazette* No. 2, page 7, of the thirteenth day of the following month, and hereinafter referred to as "the said Proclamation":

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in me by the said Act, do hereby alter or amend the said Proclamation as follows—namely, by omitting therefrom the Second Schedule and all reference to the closing of the road mentioned in such Schedule, and by substituting the words "river-bed" for the words "Crown land" wherever they occur in the First Schedule to the said Proclamation.
