

II, Ranginui Survey District, Sections 10, 9, 8, 7, 6, Block XIV, Wharepapa Survey District, and Sections 16 and 15, Block X, Wharepapa Survey District, to the south-eastern corner of Section 3, Block X, Wharepapa Survey District; thence by the southern boundary of that section and Sections 2 and 3, Block 9, and Rangitoto A No. 10B to a road-line; thence following that road along the eastern and southern boundaries of a Crown lands block to its intersection with a line on the south-western corner of the said Crown land; thence in a north-westerly direction following that line along the south-western boundaries of the said Crown land, Rangitoto A 18B, Section 2, and Rangitoto A 21B, Section 2, to its intersection with a road forming the western boundary of Section 2, Block VII, Mangaorongo Survey District; thence following that road along the western boundary of Sections 2 and 1, Block VII, Mangaorongo Survey District, to the north-western corner of the latter section; thence by the northern boundary of Section 3, said Block VII, to its intersection with a line on the south-western boundary of Rangitoto A No. 21A 2B; thence following that line to its intersection with the northern boundary of such last-named block; thence along such boundary to its intersection with the western boundary of Rangitoto A No. 52; thence in a northerly direction by the western boundaries of Rangitoto A 52, Section 1, Block III, Mangaorongo Survey District, Rangitoto A No. 54, and Section 4, Block XV, Puniu Survey District, to the southern boundary of Section 5 of Rangitoto A No. 1, Lot 2; thence along such boundary to its junction with a road-line, and following that road on the western boundary of Sections 5 and 4 of Rangitoto A No. 1, Lot 2, to the north-western corner of said Section 4; thence along the south-western and western boundaries of Rangitoto A 53B to its intersection with a line on the western boundary of the Tokanui Hospital Reserve; thence by that boundary to its intersection with a road-line; thence by that road along the western boundary of Tokanui C No. 10 and Tokanui B; thence by the south-western and western boundaries of Tokanui A, following the road on such western boundary to its junction with the Puniu Stream; thence following that stream to the westernmost corner of Section 77, Puniu Parish; thence by a road along the northern boundary of that section, and the western boundary of Sections 68, 67, 66, 65, and 13, and the north-western boundary of said Section 13, and the south-western boundary of Section 138; thence by the north-western boundary of said Section 138 and the north-eastern boundary of Section 139; thence by a line from the northernmost corner of said Section 139 to the commencing-point.

SECOND SCHEDULE.

THE AWAMUTU-PUTARURU RAILWAY DISTRICT.

ALL that area in the Auckland Land District, situated in the Waipa, West Taupo, and Matamata Counties, commencing at the north-western corner of Allotment 134, Puniu Parish; thence in a south-easterly direction by a road forming the north-eastern boundary of said allotment, across a road, and thence generally in a north-easterly, easterly, and south-easterly direction by the said road along the north-western boundary of Allotments 7, 5, 4, and 3 of said parish, and the northern and north-eastern boundaries of said Allotment 3, across a road, and by the north-eastern boundaries of Allotments 16 and 19 of said parish, the north-western boundary of said Allotment 19, across a road, and by the north-western and northern boundaries of Allotment 20 of said parish; thence generally in a south-eastern direction by the said road along the north-eastern boundary of Allotments 20 to 29 (inclusive), across a road, and by the eastern boundary of Allotment 31 of said parish to the boundary between the Waipa and West Taupo Counties; thence in a north-easterly direction by the said county boundaries to the northernmost corner of Puahue No. 1A No. 1 Block, as shown on Plan No. 3354A, deposited in the office of the District Land Registrar at Auckland; thence generally in a south-easterly direction by the road shown on said plan, across a road, and by the road forming the north-eastern boundary of the Puahue Block, shown on Plan No. 3374A, deposited in the office of the District Land Registrar at Auckland, to a point the production of the southern boundary of Lot 7, shown on Plan No. 7793, deposited in the office of the District Land Registrar at Auckland; thence by a line to and by the southern boundary of aforesaid Allotment 7, the eastern boundary of last said allotment, and the southern boundary of Lot 6, shown on the last said plan; thence again in a south-easterly direction by the eastern boundary of Allotment 8, shown on said last plan, and part of the south-east boundary of Pukekura No. 14 to its southernmost corner; thence in a north-easterly direction generally by the south-east and eastern boundary of said Pukekura No. 14 and Part 13 of Pukekura Block aforesaid to the north-western corner of Maungatautari No. 1A Block, shown on

Plan No. 3572A, deposited in the office of the District Land Registrar at Auckland; thence by the northern and eastern boundaries of last said block to and by the northern boundary of Maungatautari No. 2A Block to and across the road forming the western boundary of Lot 7, shown on Plan No. 2938A, deposited at the office of the District Land Registrar at Auckland; thence by the said road to the northernmost corner of Section 10, shown on Plan No. 4430A, deposited at the office of the District Land Registrar at Auckland, across a road, and by a road forming the western boundary of Section 9, shown on Plan No. 7038A, deposited at the office of the District Land Registrar at Auckland, across a road, and by the western boundary of Section 8, across a road, and by the western boundary of Section 4, shown on last said plan, to the Waikato River; thence in an easterly direction by the Waikato River to the confluence of the Pairere Stream forming the western boundary of Section 22, shown on Plan L.T. 4275A, deposited at the office of the District Land Registrar at Auckland; thence by the north-western and north-eastern boundaries of said Section 22 to a road; thence in a south-easterly direction by the said road along the eastern boundaries generally of Sections 22 aforesaid, 23, 24, 25, 26, 27, and 28 to a point the production of the northern boundary of Section 21, shown on Plan L.T. 4278A, deposited at the office of the District Land Registrar at Auckland; thence by a line across the last said road to and by the northern boundary of Section 21 aforesaid, and by the eastern boundary of said Section 21 and that boundary produced across a road; thence by the northern and eastern boundaries of Section 31, shown on Plan No. 4278A aforesaid, and eastern and southern boundaries of Section 32 (quarry reserve); thence by the access road to said quarry reserve, to and across the road forming the eastern boundaries generally of Sections 42, 43, and 44 to a point the production of the northern boundary of Section 41, shown on Plan L.T. 7337, deposited in the office of the District Land Registrar at Auckland; thence across a road, and by the said northern boundary of Section 41 and the eastern and south-eastern boundaries of said section; thence by the eastern and south-eastern boundaries of Section 7, Block V, Patetere North Survey District, to a point in line with the eastern boundary of Section 6 of aforesaid block; thence by a line across a road to and by the eastern boundary of last said section; thence by the northern boundary of Section 12, Block X, of aforesaid survey district, and eastern boundary of said section to the Waotu-Putaruru Road, across the last said road, and by the road forming the eastern boundary of Section 14, Block X aforesaid; thence by the road forming the southern boundary of Section 14 aforesaid and Section 13 of aforesaid block to a point the production of the south-east boundary of Section 23 of Block X aforesaid; thence by a line across a road to and by the south-east boundary of aforesaid section, and that boundary produced across a road to and by the eastern boundary of Section 54, Block IX of aforesaid survey district, and the eastern and southern boundaries of Sections 1 and 3 of Block XIII of aforesaid survey district, across a road, and by the southern boundary of Section 2, Block XIV of aforesaid survey district, to the western boundary of Lot 1 of Section 41, Selwyn Settlement; thence in a southerly direction by said western boundary and the eastern boundaries of Waotu North Nos. 2F and 2G 1 Blocks; thence by the southern boundaries of Waotu North Nos. 2G 1 and 2G 2 Blocks to the north-east corner of Waotu South C No. 6 Block, and by the eastern boundary of said block to the northern boundary of Waotu South No. 10B; thence by said northern boundary and the northern boundaries of Waotu South Nos. 12 and 13, and by the eastern boundary of last said block and that boundary produced across a road; thence by the northern boundary of Waotu South No. 10C and the eastern boundary of said block; thence by the southern boundaries of last said block and Waotu South No. 14 and part No. 9 Block to the north-eastern corner of part Matakuku No. 3 Block; thence by the eastern, northern, and again by the eastern and southern boundaries of aforesaid block, by the eastern and southern boundaries of Matakuku No. 2B No. 2 Block, and the southern boundaries of Matakuku Nos. 2F 2 and 2G 2 Blocks to the Waikato River; thence by the right bank of said Waikato River in a southerly direction to a point in line with the production of south-east boundary of Wharepunga No. 19; thence by a right line across the said river to and by the said south-east boundary of Wharepunga No. 19 to the eastern boundary of Section 1, Block III, Ranginui Survey District; thence by the eastern and southern boundaries of said section, and the southern boundaries of Sections 2, 3, 4, and 5 of said block, and the southern boundary of Section 1 of Block II of aforesaid survey district, across a road, and by the southern boundary of Section 4 of said Block II; thence in a northerly direction by the western boundaries of Sections 4 and 3 of said Block II, and western boundaries of Sections 10 and 9 of Block XIV, Wharepapa Survey District, part of northern boundary of Section 9 aforesaid, and the western boundaries
