

stream forming the boundary of the Pukekura Road District to the Waikato River; thence in a south-easterly direction by the Waikato River to the boundary of the Parish of Pukekura; thence generally in south-westerly and south-easterly directions, following said parish boundary to its intersection with the boundary-line between the Waipa and West Taupo Counties; thence in a north-easterly direction by said boundary-line to the northernmost corner of Puahue No. 1F; thence in south-easterly and south-westerly directions by the north-eastern and south-eastern boundaries of Puahue No. 1F to the northernmost corner of Puahue No. 2, Section 9; thence in southerly-easterly direction by the north-easterly boundaries of Puahue No. 2, Sections 9 and 8; thence in north-easterly and south-easterly directions by the north-western boundary of Maungatautari No. 4H and the north-eastern boundaries of Maungatautari Nos. 4H, 4H 4B, and 4H 1; thence in a north-easterly direction by the north-western boundaries of Maungatautari Nos. 4G 2 and 4G; thence in easterly and south-westerly directions by the north and south-eastern boundaries of Maungatautari No. 4G to the northernmost corner of Section 31, Block VII, Maungatautari Survey District; thence in a south-easterly direction by the north-eastern boundaries of said Section 31 and Sections 30, 12, and 29, Block XI, said survey district, to the Waiteti Stream; thence following said stream to the Waikato River; thence generally towards the south-west by said river to the Mangare Stream; thence generally towards the west and south-west by the southern boundaries of Sections 7A and 26, Block XV, Maungatautari Survey District, and Section 25, Block XI, said survey district, and Maungatautari No. 4F, and the south-eastern boundary of Section 4, Block XIII, Maungatautari Survey District, to the Puniu River; thence generally in a westerly direction by the said river to its intersection with the northern boundary of Wharepuhunga No. 11; thence towards the west and south-west by the northern boundary of Wharepuhunga No. 11 and the north-western boundaries of Wharepuhunga Nos. 11, 12A 2c 2, and 12A 2B; thence towards the south-east by the south-western boundary of Wharepuhunga 12A 2B; thence towards the south-west by the south-eastern boundaries of Wharepuhunga No. 5F, Korakonui No. 4, and Sections 12, 7, 8, and 9, Block IV, Mangaorongo Survey District; thence towards the north-west by the south-western boundaries of Sections 9 and 10, Block IV, Mangaorongo Survey District; thence towards the north-east by the north-western boundaries of Sections 10 and 11, said block and survey district; thence towards the west by southern boundaries of Sections 3 and 2, said block and survey district, and Rangitoto A No. 54; thence towards the north by western boundaries of Rangitoto A No. 54 and Section 4, Block XV, Puniu Survey District, to the south-eastern boundary of Lot 5 of Rangitoto A No. 1; thence towards the south-west by the south-eastern boundaries of said Lot 5 and Lots 2 and 1 of Rangitoto A No. 1; thence towards the north by the western boundary of said Lot 1; thence generally towards the west and south-west by the north and north-western boundaries of said Rangitoto A No. 1 to the boundary-line between the West Taupo and Waitomo Counties; thence towards the north-west by such boundary-line to the southern boundary of Ouruwhero No. 1; thence towards the west by the southern boundaries of Ouruwhero Nos. 1C and 1A, Native reserve, Section 13, Block XIII, Puniu Survey District, Section 23, Block XVI, Pirongia Survey District, and Ouruwhero 3F No. 2 to the Waipa River; thence generally towards the north, following said river to the commencing-point. As the same is more particularly delineated on plan marked P.W.D. 47526, deposited in the office of the Minister of Public Works, at Wellington, and thereon edged in pink.

SECOND SCHEDULE.

OUTER AREA.

ALL that area of land in the Waitomo County, in the Auckland Land District, comprising the Township of Otorohanga and portions of the Te Rauamoia and Otorohanga Ridings of the said county: Bounded (commencing at the point of intersection of the line forming the boundary between the West Taupo and Waitomo Counties and the northern boundary of Section 3, Block XIII, Puniu Survey District) in a south-easterly direction by the boundary-line between the said counties to its intersection with the Mangaorongo Stream; thence in a south-westerly direction, following the north-western boundaries of Rangitoto-Tuhua 29C, Sections 2H and 2E, and Rangitoto-Tuhua 28B, Sections 2C and 2A, to the southernmost corner of Mangawhero No. 1E; thence towards the north-west and north by the south-western and western boundaries of Mangawhero No. 1E to the southern boundary of Mangawhero 2C; thence towards the west and north-west by the southern and south-western boundaries of Mangawhero 2C; thence towards the west

by the southern boundaries of Mangawhero 3B 3C and 3D 4; thence towards the north-west by the south-western boundaries of Mangawhero 3D 4 and Whareraurekau No. 3; thence towards the west and south-west by the southern boundary of Section 5, Block VIII, Orahiri Survey District, and south-western boundary of Orahiri No. 7C No. 1 to the Otorohanga-Te Kuiti Road; thence towards the north by the said road to its intersection with the north-eastern boundary of Orahiri No. 1, Section 32; thence towards the north-west and south-west by the north-eastern and north-western boundaries of said section to the southern boundary of Section 2A, Block VIII, Orahiri Survey District; thence towards the west by said boundary to the Waitomo Stream; thence towards the south by said stream to the easternmost corner of Section 5, Block VII, Orahiri Survey District; thence towards the north-west by the north-eastern boundaries of said section and Section 12, Block III, Orahiri Survey District, to the Te Pahi Road; thence towards the south-west by the said road to the south-western boundary of Section 8, Block III, said survey district; thence towards the north-west by said boundary to the south-eastern boundary of Section 7, said block; thence towards the south-west, north-west, and north-east, respectively, by the south-eastern, south-western, and north-western boundaries of said Section 7 to the south-western boundary of Section 19, Block III, Orahiri Survey District; thence towards the north-west by the south-western boundaries of Sections 19, 20, and 21, said block; thence towards the north-east and south-east respectively by the north-western and north-eastern boundaries of said Section 21 to the westernmost corner of Section 8, Block XV, Pirongia Survey District; thence generally towards the north-east by the north-western boundaries of said Section 8, Maungarangi 2B 1, and Section 7, said block; thence towards the east by the northern boundary of said Section 7 to the south-western boundary of Section 8, Block XVI, Pirongia Survey District; thence towards the north-west by the south-western boundary of said Section 8; thence towards the north-east by the north-western boundaries of Sections 8, 10, and 7, Block XVI, said survey district; thence towards the north-west by the south-western boundaries of Sections 7, 5, and 3, said block, to the north-western boundary of said Section 3; thence towards the north-east, north-west, and again north-east by the north-western, south-western, and again north-eastern boundaries of said Section 3 to the Otorohanga-Pirongia Road; thence towards the north-west by said road to the north-western boundary of Section 4, Block XII, Pirongia Survey District; thence towards the north-east along said boundary to the Waipa River; thence generally towards the south by said river to the southern boundary of Ouruwhero 3F No. 2; thence towards the east by the southern boundaries of Ouruwhero 3F No. 2, Section 23, Block XVI, Pirongia Survey District, Section 13, Block XIII, Puniu Survey District, Native reserve, and Ouruwhero Nos. 1A and 1C to the commencing-point. As the same is more particularly delineated on the plan marked P.W.D. 47526, deposited in the office of the Minister of Public Works, at Wellington, and thereon edged neutral tint.

THIRD SCHEDULE.

TE AWAMUTU ELECTRIC-POWER DISTRICT.

ALL that area in the Auckland Land District comprising the Borough of Te Awamutu, the town districts of Kihikihi and Ohaupo, portions of the counties of Waitomo and Waipa, the road districts of Rangiaohia and Kakepuku, and portions of the road districts of Pukekura, Wharepapa, and Parawera: Bounded by a line commencing at the junction of the Mangao-tama Stream and the Waipa River, and proceeding along the northern boundary of the Ngaroto Parish to the westernmost corner of Allotment 362, Te Rapa Parish; thence along the north-western and north-eastern boundaries of the said allotment to the Ohaupo-Hamilton Road; thence northerly along the said road to and along Mystery Stream to the Waikato River; thence up the Waikato River to the western boundary of the Pukekura Parish, and along that boundary to a point in line with the north-eastern boundaries of Allotments 156, 157, and 158, Puniu Parish; thence to and along those boundaries to the north-western boundary of the Puahue Block, and north-westerly along that boundary to the northernmost point of Puahue No. 1F Block; thence south-easterly along the north-eastern boundary of the said block, the northern boundaries of that part of Puahue No. 2 Block shown on deposited plan 2209A, Puahue 2 No. 5A, Puahue 2 No. 6B, and Puahue 2 No. 7B; thence south-westerly along the north-western boundary of Maungatautari No. 4H 8 Block to the northernmost corner of Maungatautari No. 4H Block, and along the north-eastern boundaries of Maungatautari Nos. 4H 4B and 4H 1; thence north-easterly along the north-western boundaries of Maungatautari Nos. 4G 2
