WHEREAS by an Order in Council dated the seventeenth day of December, one thousand nine hundred and seventeen, made under the Animals Protection Act, 1908, it was ordered and declared that the season during which godwits may be killed shall be the first day of January to the thirty-first day of March, both days inclusive, in each year, except in the Opotiki, Southland, and Auckland Acclimatiza-tion Districts: And whereas it is expedient to amend the said Order in Council:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in him by the said Animals Protection Act, 1908, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby order and declare that the season during which godwits (*Limosa Novæ Zealandiæ* — native name Kauka or Hakakao) may be killed shall, except in the Opotiki and Southland Acclimatization Districts, be the first day of January to the thirty-first day of March, both days inclusive, in each year; provided that no such birds shall be trapped, netted, snared, or taken by any other means prohibited by the Animals Protection Act, 1908.

CONDITIONS. 1. THE licensee shall pay to the Marine Department a rental in advance each year of 1s. per acre per annum, the first of such annual payments to be made on the licensee being supplied with a copy of this Order in Council. 2. The licensee shall keep any stop-banks which he may construct for the purpose of reclaiming the land included in this license in good order and condition, and shall provide and maintain all necessary outlets for storm-water. 3. The licensee shall keep the land included in this license free from novious weeds.

a. The licensee shall not assign, charge, or part with any right, power, or privilege granted by this license without the previous written consent of the Minister of Marine.
