IN exorcise and pursuance of the powers and authorities vested in me by the Animals Protection Act, 1908, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor - General of the Dominion of New Zealand, do hereby appoint those parts of the said Dominion described in the Schedule hereto to be a district under and for the purposes of the said Act, and I do hereby declare that such District shall be known as the Nelson Acclimatization District.
