Bounded towards the north by Maimai Survey District; towards the south-east generally by national-endowment lands; towards the south and south-west by Otututu River. As the same is delineated on the plan marked 82, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered red.

All that area of Crown land in the Nelson Land District, containing by estimation 14,900 acres, more or less, situated in Blocks I, II, V, VI, IX, and X, Rahu Survey District. Bounded towards the north by Burnett Survey District; towards the north-east, south-east, south, and south-west generally by the edge of the forest; towards the west by Waitahu Survey District; and towards the north-west by national-endowment lands. As the same is delineated on the plan marked 82, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered red.

All that area of Crown land in the Nelson Land District, containing by estimation 75,130 acres, more or less, situated in Blocks I to XVI, Waitahu Survey District, and Blocks V and IX, Rahu Survey District. Bounded towards the south-west by Section 1 of Square 17; on the north-west and south-east generally by West Haven Inlet. As the same is delineated on the plan marked 70, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered red.

All that area of Crown land in the Nelson Land District, containing by admeasurement 85 acres, more or less, and being Section 13, Block V, Pakawau Survey District. Bounded towards the south by Section 1 and a road; and towards the west and east generally by the left branch of the Wairoa River.
