Importation of Apples from New Zealand into the Territory of Hawaii.—Notice No. 1992.

THE following extract from a rule made by the Board of Commissioners of Agriculture and Burnelline and Burnelli Commissioners of Agriculture and Forestry of the Territory of Hawaii, permitting the introduction of fresh apples from New Zealand, is published for general information:—

"Fresh apples may be imported into the territory of Hawaii direct from New Zealand in cold storage only, if they are free from insect pests and plant diseases, and are accompanied by a Government certificate declaring that the apples have been grown in New Zealand and are shipped free from insect pests and plant diseases, and are also accompanied by a Government certificate declaring that they have not and will not come in contact with Australian grown fruit on the voyage to the territory of Hawaii."
