HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by section forty-six of the Land Laws Amendment Act, 1913, it is enacted that the Go-vernor-General may, by Order in Council gazetted, on the recommendation of the Land Board, declare that any land comprised in a kauri-gum reserve shall, from a date to be specified in the Order, cease to be subject to the Kauri-gum Industry Act, 1908, and on and after the date so specified the land to which the Order relates shall become subject to the provisions of the Land Act, 1908: And whereas the Land Board of the North Auckland Land District the aduly passed a resolution recommending that the

District has duly passed a resolution recommending that the portion of the Otaika Kauri-gum Reserve Extension No. 2 described in the Schedule hereto be excepted from the operations of the Kauri-gum Industry Act, 1908, and it is expedient to give effect to such recommendation:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority conferred upon me by section forty-six of the Land Laws Amendment Act, 1913, and acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby order and declare that the portion of the Otaika Kauri-gum Reserve Extension No. 2 described in the Schedule hereto shall, from the twenty-seventh day of May, one thousand nine hundred and twenty, cease to be subject to the Kauri-gum Industry Act, 1908.

SCHEDULE.

ALL that area in the North Auckland Land District, situated in Blocks IV and VI, Tangihua Survey District, and containing by admeasurement 1,528 acres, more or less, being the Otaika Kauri-gum Reserve Extension No. 2, as described in Otana Rauri-gum reserve Extension No. 2, as described in the New Zealand Gazette No. 79, of the 28th September, 1899, page 1837, excepting Sections 139 and 145, both of the Parish of Maungatapere, and an area of 360 acres, which have been withdrawn from the reserve.
