WHEREAS by section one hundred and twenty of the Public Works Act, 1908 (hereinafter called "the said Act "), it is, *inter alia*, enacted that the Governor-General may, by Warrant under his hand publicly notified and gazetted, direct that any bridge already constructed, or which may hereafter be constructed, over or across any river or arm of the sea respectively shall, from and after a date to be fixed in such Warrant, be under the exclusive care, control, and wareareant of such lead authority as is warficened in and management of such local authority as is mentioned in that behalf in such Warrant; and may by any such Warrant as aforesaid fix and determine whether all or any, and (if so) as abressid in and determine whether an or any, and (it so) what part, of the cost, whether theretofore incurred or there-after to be incurred, of maintaining, repairing, improving, or reconstructing any such bridge is to be provided and paid by the local authority or local authorities; and may by any such Warrant as aforesaid direct how, when, and to whom any such payment is to be made :

And whereas by the said section one hundred and twenty it is, *inter alia*, provided that the Governor-General may, with the view of determining what proportion (if any) of the cost of maintaining, repairing, improving, or reconstructing any such bridge should be borne by any local authority or local authorities, direct any Magistrate or other person to be a Commissioner to inquire and report to him upon any matter which he shall deem necessary to enable him to determine any such question as aforesaid : And whereas a Commissioner was appointed for the purpose

as aforesaid, and an inquiry duly held :

And whereas such Commissioner did report to the Governor-General, after due inquiry, his opinion thereon : And whereas the Governor-General is of opinion that it is

equitable that the cost of maintaining, repairing, improving, or reconstructing the bridge mentioned in the Schedule hereto should be provided and paid in the manner hereinafter set forth:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and autho-rities vested in me by the said Act, and of every other power and authority in anywise enabling me in this behalf, do hereby direct that the bridge described in the Schedule hereto (and hereinafter called "the said bridge") shall, from hereto (and hereinatter called "the said bridge") shall, from and after the date of gazetting hereof, be under the exclusive care, control, and management of the Kairanga County Council; and, in further pursuance and exercise of the powers aforesaid, I do hereby fix and determine that the cost of maintaining, repairing, improving, or reconstructing the said bridge shall be borne by the Kairanga County Council.

THAT bridge, situated in the Wellington Land District, over the Oroua River at Mangawhata, between Glen Oroua and Rangiotu, on the Hoihere Road. As the site of the said bridge is more particularly delineated on the plan marked P.W.D. 46598, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon marked with a red cross
