DESCRIPTION.

This block lies on the south side of the Ongarue River, about four miles and a half to seventeen miles eastward from Waimiha Railway-station by roads which have not yet been formed; but provision has been made for the construction of necessary formed access. There are several horse and foot tracks which traverse different parts of the horse and foot tracks which traverse different parts of the block, and a stock-bridge has been erected over the Ongarue River leading to the sections.
