

Crown land and the edge of the forest; towards the south-east and south generally by Crown land; and towards the west by the Aorere River. As the same is delineated on plan marked 71, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 2,750 acres, more or less, situate in Blocks I and V, Whakapoi Survey District. Bounded towards the north by part of the northern boundary of the aforesaid survey district; towards the east and south-east generally by Lewis Creek, a public road, Sections 1 to 14 of Block I aforesaid, and Sections 1 to 4 of Block V aforesaid; towards the south by national-endowment land; and towards the west by the Tasman Sea. As the same is delineated on plan marked 71, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Bounded towards the north-east generally by Gunner Creek and Crown land; towards the south-east generally by the Collingwood County boundary; towards the west by part Run 23 and Crown land; and towards the north-west generally by part Run 23 and Crown land. As the same is delineated on plan marked 71, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 5,000 acres, more or less, situate in Blocks VII, XI, XII, XV, and XVI, Ohika Survey District. Bounded towards the north-west and north-east generally by Reserve 9 (in red); and towards the south-east and again towards the north-west by Crown land. As the same is delineated on plan marked 76, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 9,800 acres, more or less, situate in Blocks IV, V, VII, VIII, and XI, Waitakere Survey District, and Blocks V and IX, Ohika Survey District. Bounded towards the north-east by Mountain Creek and Crown land; towards the south-east by the boundary of the Buller Coalfield Reserve; towards the south and again to the east by Crown land; again towards the south by national-endowment land; towards the south-west by Sections 6 and 5, Block VII, Waitakere Survey District; and towards the north-west generally by the edge of the forest. As the same is delineated on plan marked 76, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 35,300 acres, more or less, situate in Blocks VII, IX, X, and XI, Waitakere Survey District, and Blocks I, II, III, IV, V, VI, VII, VIII, X, XI, and XV, Brighton Survey District. Bounded towards the north generally by Section 4, Block VII, Waitakere Survey District; by a road along the left bank of the said river, a line across the said road and river and another road, Sections 7 and 6, Block VII aforesaid, and national-endowment land; towards the east and south-east generally by Crown land and the edge of the forest to Bullock Creek; towards the south and south-east generally by a road along the right bank of the aforesaid river, by a block of Crown land (1,186 acres), by an inland road, by Section 1, Block X, Brighton Survey District, and Crown land; towards the west generally by Section 11, by the southern, eastern, and northern boundaries of Section 10, Sections 3 and 9, all in Block V aforesaid; thence by a line across a road, Fox's River, and another road, by that last-mentioned road along the right bank of the said Fox's River; thence by a road from the south-eastern corner of Section 25, Block I, aforesaid, to the south-western corner of Section 3, Block II aforesaid; thence by the southern and eastern boundaries of the said Section 3, by part of the south-western, by the eastern and northern boundaries of Section 2, Block II, aforesaid, by a road, a block of Crown land (850 acres), by part of the Charleston and Brighton Road and the edge of the forest: save and except three blocks of Crown land indicated on plan mentioned below, as 1,280 acres, 660 acres, and 116 acres, and all public roads within the above-described boundaries. Bounded towards the north-west, west, and north generally by the boundary of the Buller County; towards the south-east, north-east, and again towards the north by Crown lands; towards the east by part of the eastern boundary of Leslie Survey

District; again towards the south-east generally by Crown lands; towards the south by part of the northern boundary of the Otumahana Survey District; thence by Jordan's Creek, a road, Section 37, Elford's Creek, Sections 28, 11, W 63, Section 38, a road, Sections 27 and 30, a line across a road, the left bank of the Karamea River, a line across that river, by a road, and Section 29, all in Block XV, Oparara Survey District; thence by Section 1, Block XI, of the said survey district, and by Crown lands; thence by a road along the eastern boundary of Section 3, Block X aforesaid, a line across a road, by that road, and roads running down to the easternmost corner of Section 86 in Block IX above mentioned; thence by that section and Sections 56 and 51, a road along the Oparara River, a line across that road, across the said river, and across a road along the right bank thereof, by Section 64, all in Block IX aforesaid; thence by Section 20, Break Creek, and Section 23, both in Block V before mentioned; thence towards the north-east, north-west, and south-west by Crown lands; thence by Section 14, a road, again by the said Section 14, by a line across Waitakura Creek, and across a road along its left bank, again by the said Section 14, by Section 7, a line across a road, and across the Waitakura Creek, by that creek, by a road and a line across that road to the south-east corner of Section 6, all in Block I before mentioned; thence by that section and Section 5 of the said block, and by a line in continuation in a northerly direction of the eastern boundary of the said Section 5 to the northern boundary of the Buller County; save and except all public roads, and a parcel of open country in Block II, Oparara Survey District. As the same is delineated on the plan marked 74, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 58,500 acres, more or less, situate in Blocks I, II, III, V, VI, VII, IX, X, XI, XII, XIV, XV, and XVI, Leslie Survey District; Blocks II, III, IV, VII, and VIII, Tasman Survey District; and Blocks V and IX, Matawai Survey District. Bounded towards the west by part of the western boundary of the Oparara Survey District; towards the north-west, north, east, and again towards the north by Crown lands; towards the south-east generally by the edge of the forest; and towards the south-west, again towards the west, and towards the south by Crown land. As the same is delineated on plan marked 74, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 20,470 acres, more or less, situate in Blocks II, III, IV, VI, VII, VIII, X, XI, XII, XIII, and XIV, Otumahana Survey District. Bounded towards the north generally by part of the southern boundary of the Oparara Survey District; towards the north-east by Crown lands; towards the east, south, and south-east by the edge of the forest; again towards the south-east by Crown lands; towards the north-west by Section 7, Block XIII, Otumahana Survey District, by a line across Macpherson's Creek, by a line across a road and by Section 16, in Block IX aforesaid, a line across a road and across West's Creek, by Section 4 in Block X aforesaid, by a line across a road and across Blue Duck Creek, again by the said Section 4, across Baker's Creek, by Section 5 in the last-mentioned Block, and again by the said Section 4; towards the west by the said Section 4, a line across Ray's Creek and across a road, by Section 3 in Block X aforesaid, a line across a road and across Prince's Creek, by Section 3 in Block VI aforesaid, a line across a creek and across a road, again by the said Section 3, a line across a creek, by Section 6 in the said Block VI, and a line across a road to the Little Wanganui River; again towards the north by that river; again towards the west by a line across that river and across a road, and by the eastern and northern boundaries of Section 11 in the said Block VI; thence by Section 2 in Block II aforesaid and by Crown land: save and except public roads lying within the above-described boundaries. As the same is delineated on the plan marked 74, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 5,460 acres, more or less, situate in Blocks XI, XII, XV, and XVI, Otumahana Survey District. Bounded towards the north-east by the edge of the forest; and towards the south and north-west by Crown lands. As the same is delineated on plan marked 74, in green, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

Also all that area of land in the Nelson Land District, containing by admeasurement 5,160 acres, more or less, situate in Blocks XII and XVI, Mokihinui Survey District, and Blocks I and V, Marina Survey District. Bounded towards the north-west generally by the Main Mokihinui-Karamea Road, Section 11 in the before-mentioned Block XII, and by the southern boundaries of the Kongahu and Otumahana Survey Districts; towards the south-east by Crown
