HIS EXCELLENCY THE ADMINISTRATOR PRESIDING IN COUNCIL.

WHEREAS application has been made, under section twenty, subsection one, of the Finance Act, 1919, for the precedent consent of the Governor-General in Council to enable the Otago Harbour Board to borrow the sum of two hundred thousand two hundred pounds, and it is expedient that such consent should issue :

Now, therefore, His Excellency the Administrator of the Government of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby consent to the raising of the loan of two hundred thousand two hundred pounds by the Otago Harbour Board, provided that the rate of interest at which the loan is to be raised shall in no case produce to the lender a return exceeding five and one-half pounds per centum per annum ; and it is hereby declared that this Order in Council is made under the provisions in that behalf of the Finance Act, 1919, and shall operate accordingly as a consent of the Governor-General in Council to the raising of the loan hereby authorized.
