WHEREAS application has been made, under section twenty, subsection one, of the Finance Act, 1919, for the precedent consent of the Governor-General in Council to enable the Wanganui Borough Council to borrow the sums of twenty thousand six hundred pounds and sixteen thousand five hundred pounds respectively, and it is expedient that such consent should issue :
